Malacca via Penang

June 1919

Underpaid letter from Ramnad, India to Malacca, Straits Settlements, Malaya. Postage is partly paid by two copies of the ½ Anna of 1912 postmarked 1 JUN 19 on the reverse. The rate was 1½ Annas and the deficiency ½ Anna.

On the obverse is an Indian "T" (Taxe) mark as well as a blue manuscript "10c" to indicate double the deficiency in French centimes. On the reverse there is a Penang transit mark of 13 JU 1919 and a boxed postage due mark "To Pay/ 4 cents". Also on the reverse the Malacca arrival mark is 16 JU 1919 as well as a boxed postage due mark "Malacca/ To Pay 4 Cents" indicating that postage due of 4 cents was charged.



Penang

June 1919

Unpaid letter from Karaikudi, India to Penang, Straits Settlements, Malaya postmarked 7 JU 19 on the reverse. The rate, and the underpayment, was 1½ Annas.

On the obverse is an Indian "T" (Taxe) mark in a circle as well as a semi-circular "Karaikudi/ Due/ As".

On the reverse there is a Penang arrival mark of 21 JU 1919 and a postage due mark "To Pay/ 12 Cents" indicating that postage due of 12 cents was charged.





Penang

June/July 1919


Underpaid letter from Colombo, Ceylon to Penang, Straits Settlements, Malaya.

Postage is partly paid by a horizontal pair of the 3 cents of 1919 postmarked JU 20 19 on the reverse.

The rate was 9 cents and the deficiency 3 cents.

On the obverse is a "T" (Taxe) mark beside a manuscript "10c" to denote double the deficiency in gold centimes. On the reverse is a Penang arrival mark is 2 JY 1919 and a "To Pay/ 4 Cents" postage due mark indicating that postage due of 4 cents was charged.





Singapore

July 1919

Underpaid letter from India to Singapore, Straits Settlements, Malaya with a copy of the 1 Anna of 1911 postmarked on the reverse 15 JUL 19. The rate was 1½ Annas and the deficiency ½ Anna. On the obverse is an Indian "T" (Taxe) mark in a circle. On the reverse is a manuscript "10c" denoting double the deficiency in French centimes, a Singapore arrival mark of 27 JY 1919 and a postage due mark in red "Singapore/ To Pay 4 Cents" indicating that postage due of 4 cents was charged.



Penang

July 1919

Underpaid letter from Devakota, India to Penang, Straits Settlements, Malaya postmarked 20 JUL 19 on four copies of the 3 Pies of 1912 on the reverse. The rate was 1½ Annas and the deficiency ½ Anna. On the obverse is an Indian "T" (Taxe) mark. On the reverse there is a pencilled mark of "10c" to denote double the deficiency in French centimes. Also on the reverse is a Penang arrival mark of 31 JY 1919 and a postage due mark "To Pay/ 4 Cents" indicating that postage due of 4 cents was charged.






Singapore

July/August 1919

Unpaid letter from Tirupatur, Ramnad, India to Singapore, Straits Settlements, Malaya postmarked on the reverse 28 July 1919. The rate and the deficiency was 1½ Annas. On the obverse are Indian "T" (Taxe) and semi-circular "Tirupatur Ramnad/ due/ As" marks.

On the reverse is a Singapore arrival mark of 9 August 1919 and a previously unrecorded "Singapore/ To Pay ... cents" mark in red with a manuscript "12" inserted indicating that postage due was 12 cents.





Singapore

August/September 1919

Underpaid letter from ... evikuppai, Ramnad, India to Singapore, Straits Settlements, Malaya postmarked 28 AUG 19 on a vertical pair of the ½ Anna of 1911 on the reverse.

The rate was 1½ Annas and the deficiency ½ Anna.

On the obverse is an Indian "T" (Tax) mark. On the reverse is a Singapore arrival mark of 12 SE 1919 and a postage due mark "Singapore/ To Pay 4 Cents" in red indicating that postage due of 4 cents was charged.



Malacca

October 1919

Underpaid letter from India to Malacca, Straits Settlements, Malaya postmarked 9 OC 19 on the reverse on a copy of the 1 Anna of 1911. The rate was 1½ Annas and the deficiency ½ Anna. On the obverse is an Indian "T" (Taxe) mark in a faint circle together with a manuscript mark of "10c" denoting double the deficiency in French centimes. On the reverse there is a transit mark of Penang of 22 OC 1919. There is also a Malacca arrival mark of 24 October 1910 and a boxed postage due mark "Malacca/ To pay 4 cents" indicating that postage due of 4 cents was charged.





Malacca December 1919

Indian PSC (local rate of ¼ Anna) from Ponnamarau/vathy, India to Malacca, Straits Settlements, Malaya postmarked 14 December 1919. The rate was 1 Anna and the deficiency ¾ Anna. On the obverse is an Indian "T" (Taxe) mark together with a manuscript "15c" denoting double the deficiency in French centimes. On the reverse there is a transit mark of Penang of 30 December 1919. There is also a Malacca boxed postage due mark "Malacca/ To pay 6 cents" indicating that postage due of 6 cents was charged on the obverse.
