

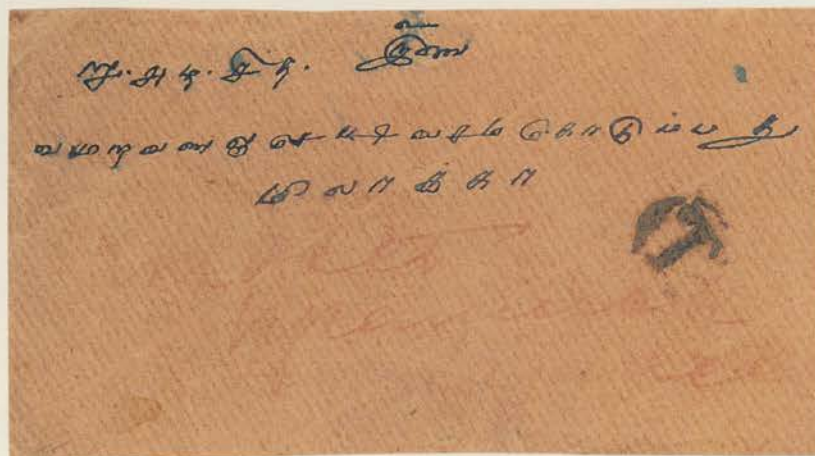
# MALAYA - STRAITS SETTLEMENTS

Malacca

September 1920

Underpaid letter from Pallatur, India to Malacca, Straits Settlements, Malaya postmarked 16 September 1920 on a copy of the 1 Anna of 1911 on the reverse. The rate was 1½ Annas, the deficiency ½ Anna.

There is an Indian "T" (Taxe) mark on the obverse. On the reverse there is a manuscript "10c" to indicate double deficiency in French centimes. There is a Malacca arrival mark of 30 September 1920 and a boxed "Malacca/ To pay 4 cents" mark to indicate postage due of 4 cents was charged.

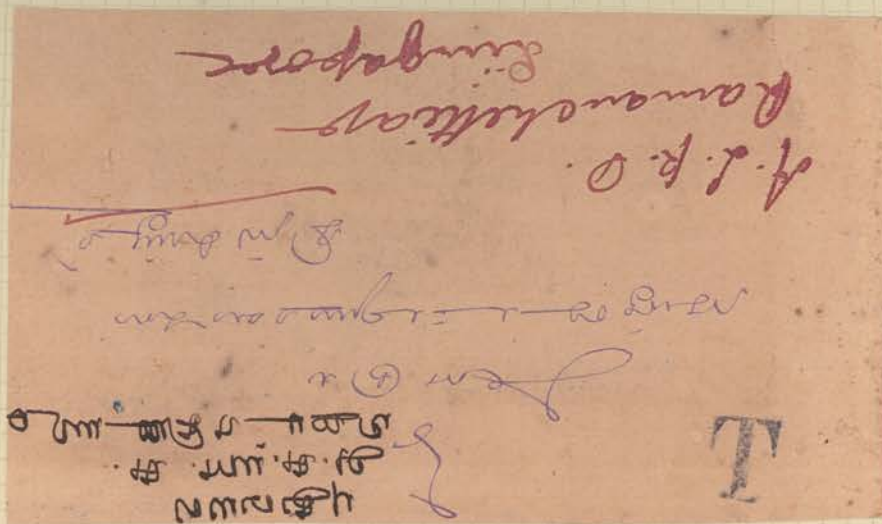
Singapore

September/October 1920

Underpaid letter from India to Singapore, Straits Settlements, Malaya with postage partly paid by a horizontal pair of the ½ Anna of 1912 on the reverse postmarked 28 SEP 20.

The rate was 1½ Annas and the deficiency ½ Anna.

On the obverse there is an Indian "T" (Taxe) mark. On the reverse there is a Singapore arrival mark of 8 OC 1920 and a boxed postage due mark "Singapore/ to pay 4 cents" in red indicating that postage due of 4 cents was charged.





# MALAYA - STRAITS SETTLEMENTS

Singapore

October 1920

Unpaid letter from Karaikudi, India to Singapore, Straits Settlements, Malaya postmarked 14 October 1920 on the reverse. The rate, and the deficiency, was 1½ Annas.  
 On the obverse is an Indian "T" (Taxe) mark as well as a semi-circular "Karaikudi/ Due/... As". On the reverse there is a Singapore arrival mark of 20 October 1920 and also a red boxed "Singapore/ To Pay ... Cents" postage due mark with a "12" inserted indicating that postage due was 12 cents.



# MALAYA - STRAITS SETTLEMENTS

Singapore

November/December 1920

Underpaid letter from India to Singapore, Straits Settlements, Malaya postmarked 28 November 1920 on a copy of the ½ Anna of 1911 on the reverse. The rate was 1½ Annas and the deficiency 1 Anna.

On the obverse is an Indian "T" (Taxe) mark. On the reverse there is a Singapore arrival mark of 10 December 1920. Also on the obverse there is a Singapore postage due mark "Singapore/ To Pay 8 cents" in red indicating that postage due of 8 cents was charged.

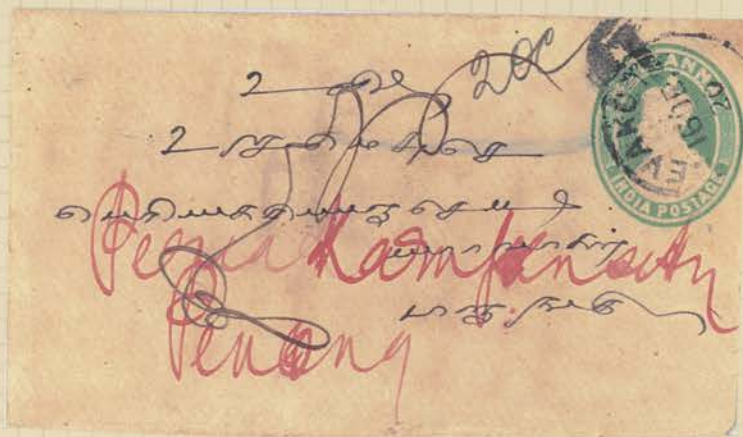
Penang

December 1920

Indian KGV Postal Stationary envelope (old internal rate of  $\frac{1}{2}$  Anna) from [D]evakot[a], India to Penang, Straits Settlements, Malaya postmarked 16 DE 20.

The rate was  $1\frac{1}{2}$  Annas and the deficiency was 1 Anna.

There is an Indian "T" (Taxe) mark on the obverse as well as a manuscript "20c" to indicate double the deficiency in French centimes. On the reverse there is a Penang arrival mark of 29 DE 1920 and a boxed mark "To pay/ 8 cents" to indicate postage due of 8 cents was charged.



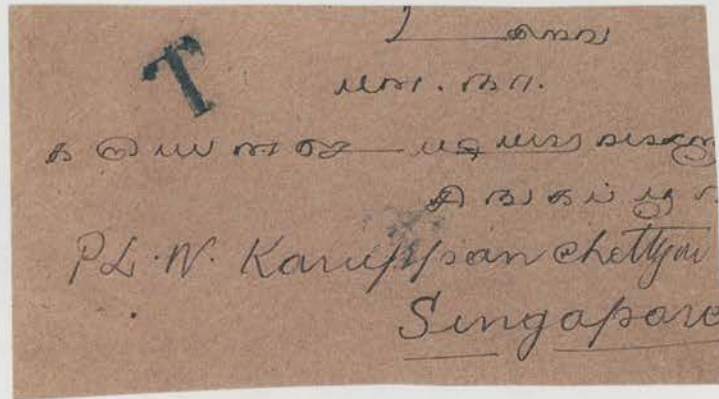


# MALAYA - STRAITS SETTLEMENTS

Singapore

January 1921

Underpaid letter from Ramnad, India to Singapore, Straits Settlements, Malaya postmarked 20 January 1921 on a copy of the 1 Anna of 1911. The rate was 1½ Annas and the deficiency ½ Anna. On the obverse is an Indian "T" (Taxe) mark. On the reverse there is a "Singapore/ To pay 4 cents" postage due mark in red indicating that postage due of 4 cents was charged.



# MALAYA - STRAITS SETTLEMENTS

Penang

January/February 1921

Unpaid letter from Nachiya[uram], Ramnad, India to Penang, Straits Settlements, Malaya postmarked 22 JAN 21 on the reverse. The rate, and the deficiency, was 1½ Annas. There is an Indian "T" (Taxe) mark on the obverse. On the reverse is a Penang arrival mark of 10 FE 1921 and a postage due mark "To Pay/ 12 Cents" indicating that postage due of 12 cents was charged.



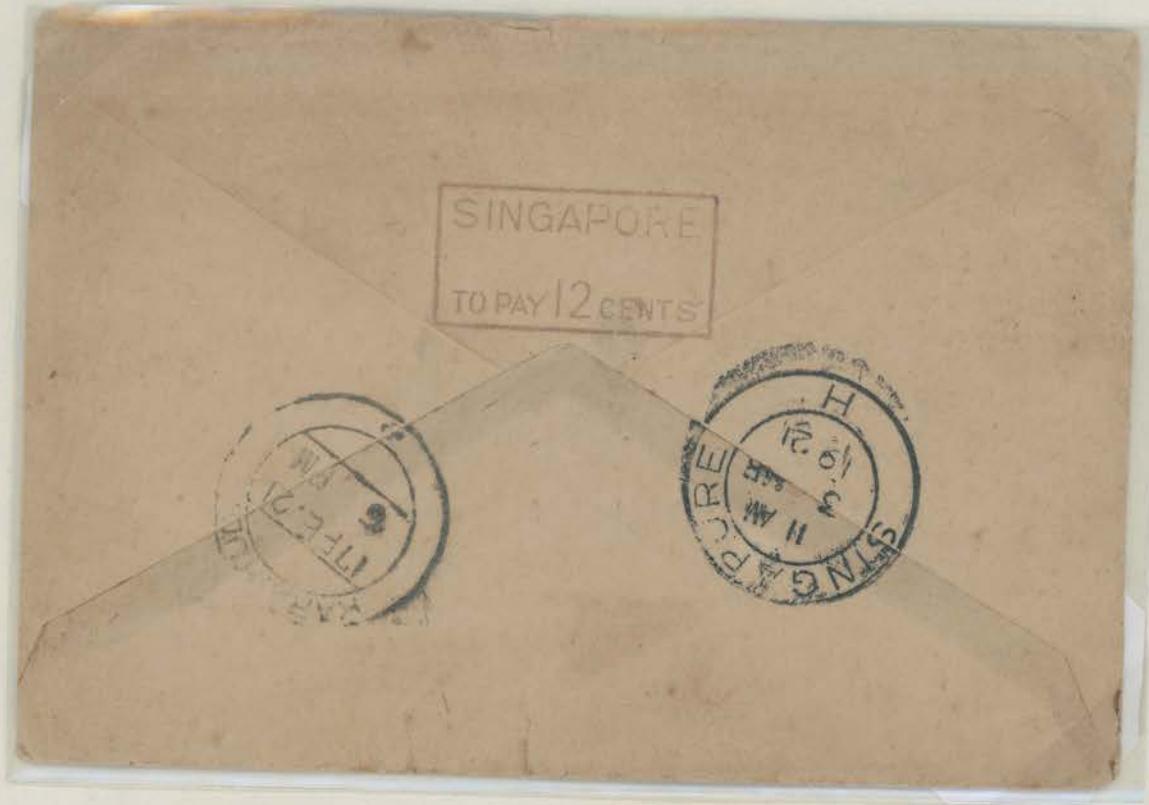
# MALAYA - STRAITS SETTLEMENTS

Singapore

February/March 1921

Unpaid letter from Karaikuda, India to Singapore, Straits Settlements, Malaya postmarked 17 February 1921 on the reverse. The rate and deficiency was 1½ Annas. On the obverse there are Indian "T" (taxe) and semi-circular "Kariakudi/ Due/ As" marks.

On the reverse there is a Singapore arrival mark of 5 March 1921 and a red boxed "Singapore/ To pay 12 cents" mark indicating that postage due of 12 cents was charged.



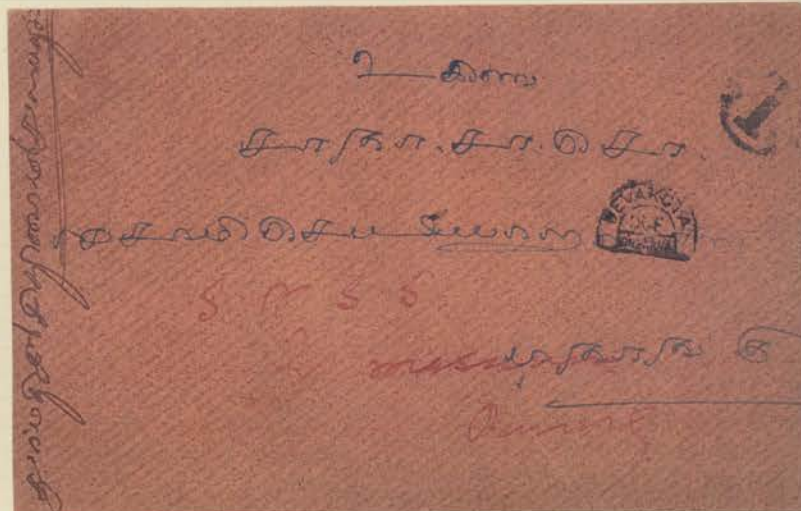


# MALAYA - STRAITS SETTLEMENTS

Penang

March 1921

Unpaid letter from Devakota, India to Penang, Straits Settlements, Malaya postmarked 14 MAR 21 on the reverse. The rate, and the deficiency, was 1½ Annas. There is an Indian "T" (Taxe) mark as well as a semi-circular "Devakota/ Due/ One Anna" on the obverse. On the reverse there is also a Penang arrival mark of 30 MR 1921 and a "To Pay/ 12 Cents" mark indicating that postage due of 12 cents was charged.



# MALAYA - STRAITS SETTLEMENTS

## Singapore

March/April 1921

Indian KGV Postal Stationary envelope (internal rate of ½ Anna) from Koonnakudi, India to Singapore, Straits Settlements, Malaya postmarked 16 MAR 21. The rate was 1½ Annas, the deficiency 1 Anna.

Also on the obverse is an Indian "T" (Tax) mark. On the reverse there is a Singapore arrival mark of 1 AP 1921 and a boxed "Singapore/ To pay 8 cents" mark in red indicating that postage due of 8 cents was charged.
