

MALAYA - STRAITS SETTLEMENTS

Penang

March 1921

Indian KGV Postal Stationary envelope (internal rate of ½ Anna) from Devak[ota], India to Penang, Straits Settlements, Malaya partly uprated on the reverse with a ½ Anna of 1912 postmarked 17 Mar 21.

The rate was 1½ Annas and the deficiency ½ Anna.

Also on the obverse is an Indian "T" (Taxe) mark. On the reverse there is a Penang arrival mark of 30 MR 1921 and a boxed "To pay/ 4 cents" mark indicating that postage due of 4 cents was charged.



MALAYA - STRAITS SETTLEMENTS

Malacca

April 1921

Indian KGV Postal Stationary envelope (old internal rate of ½ Anna) from Kothamangalam, India to Malacca, Straits Settlements, Malaya postmarked 3 April 1921. The rate was 1½ Annas and the deficiency was 1 Anna.

There is an Indian "T" (Tax) mark on the obverse as well as a manuscript "20c" to indicate double the deficiency in French centimes. There is a transit mark of 4 April 1921 on the reverse. On the reverse there is also an arrival mark of Malacca of 15 April 1921 and a boxed "Malacca/ to pay 8 cents" mark to indicate 8 cents postage due was charged.



STRAITS SETTLEMENTS - FEDERATED MALAY STATES

Malacca to Negri Sembilan

April 1921

Underpaid letter from Malacca, Straits Settlements to Kuala Pilah, Negri Sembilan, FMS postmarked 6 April 1921. A stamp (3 cents of 1913?) which had been on the reverse has been removed.

The rate was 4 cents and the deficiency was 1 cent.

There is a Malacca "T" (Taxe) mark in a circle on the obverse. On the reverse is a transit mark of Seremban of 8 April 1921 as well as a previously unrecorded rectangular "Malacca/ To pay 2 cents" mark to indicate 2 cents postage due was to be charged.



MALAYA - STRAITS SETTLEMENTS

Singapore

April 1921

Indian KGV Postal Stationary envelope (old internal rate of ½ Anna) initially from Mount Road to Madras, India postmarked 16 April 1921. The addressee had moved and the letter was readdressed to Singapore, Malaya. The rate to Malaya was 1½ Annas and the overall deficiency was 1 Anna. There is an Indian "T" (Taxe) mark on the obverse as well as a red manuscript "10c" to indicate the single (not double deficiency) unpaid postage in French centimes. There is also a red boxed "Singapore/ to pay 4 cents" mark to indicate 4 cents postage due was charged. On the reverse there are Madras transit marks of 17 and 23 April 1921.



MALAYA - STRAITS SETTLEMENTS

Singapore

Underpaid letter from St. Petersburg, Florida, USA to Singapore, Straits Settlements, Malaya postmarked 2 March 1921 on a copy of the 2 cents of 1919.

The rate was 5 cents and the deficiency 3 cents.

There is a transit New York "T/ n.y." "Centimes/ 30/ E" (Taxe) mark indicating double the deficiency in French centimes. In Malaya a boxed "Singapore/ to pay 12 cents" mark in red was applied and there is an arrival mark on the reverse of Tanglin of 21 April 1921.



MALAYA - STRAITS SETTLEMENTS

Singapore

May 1921

Underpaid letter from Naohiyapubam, Ramnad, India to Singapore, Straits Settlements, Malaya postmarked 11 May 1921 on the reverse on a copy of the 1 Anna of 1911.

The rate was 1½ Annas and the deficiency ½ Anna.

Also on the obverse is an Indian "T" (Tax) mark. On the reverse there is a Singapore arrival mark of 22 May 1921 and a "Singapore/ To pay 4 cents" mark in red indicating that postage due of 4 cents was charged.

Singapore

May 1921

Indian KGV Postal Stationary envelope (internal rate of ½ Anna) from Koonnakudi, Ramnad, India to Singapore, Straits Settlements, Malaya postmarked 2 May 1921.

The rate was 1½ Annas and the deficiency 1 Anna.

Also on the obverse is an Indian "T" (Taxe) mark. On the reverse there is a Singapore arrival mark of 13 May 1921 and a "Singapore/ To pay 8 cents" mark in red indicating that postage due of 8 cents was charged.



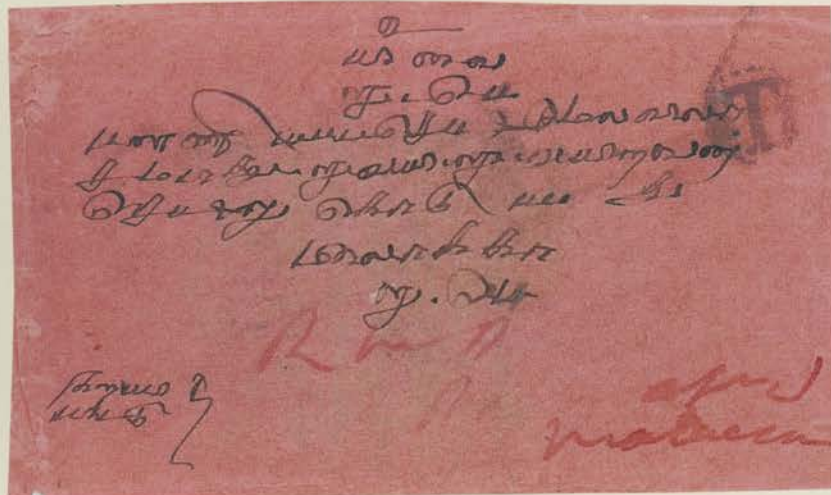
MALAYA - STRAITS SETTLEMENTS

Malacca

July 1921

Unpaid letter from Kottaiyur, India to Malacca, Straits Settlements, Malaya postmarked 23 July 1921 on the reverse. The rate and the deficiency was 1½ Annas.

On the obverse there is an Indian "T" (tax) mark. On the reverse there is a boxed "Malacca/ To pay 12 cents" mark denoting that postage due of 12 cents was charged.



MALAYA - STRAITS SETTLEMENTS

Penang

September 1921

Underpaid Indian KGV PSE (old internal rate of ½ Anna) from Karaikudi, India postmarked 7 September 1921 partly uprated by a copy of the 1 Anna of 1911 on the reverse to Penang, Straits Settlements, Malaya. The rate was 2 Annas, and the deficiency ½ Anna. On the obverse is an Indian "T" (Tax) mark with a red manuscript "10c" on the reverse to denote double the deficiency in French centimes. Also on the reverse there are Penang boxed "To Pay/ 8 cents" and "To Pay/ 4 cents" marks to denote the postage due charged. The former was applied in error and has been cancelled by a copy of the Penang obliterator.
