

MALAYA - STRAITS SETTLEMENTS

Malacca

January 1922

Underpaid KGV PSE (old local rate of ½ Anna) from Kothamangalam, Ramnad, India to Malacca, Straits Settlements, Malaya postmarked 5 January 1922. The rate was 2 Annas and the deficiency 1½ Annas. There is an Indian "T" (Taxe) mark and a manuscript "30c" to indicate double deficiency in gold centimes.

On the reverse is an Indian transit mark of 6 January 1922. There is also a boxed "Malacca/ to pay ... cents" with a manuscript "10" inserted indicating that postage due was 10 cents.

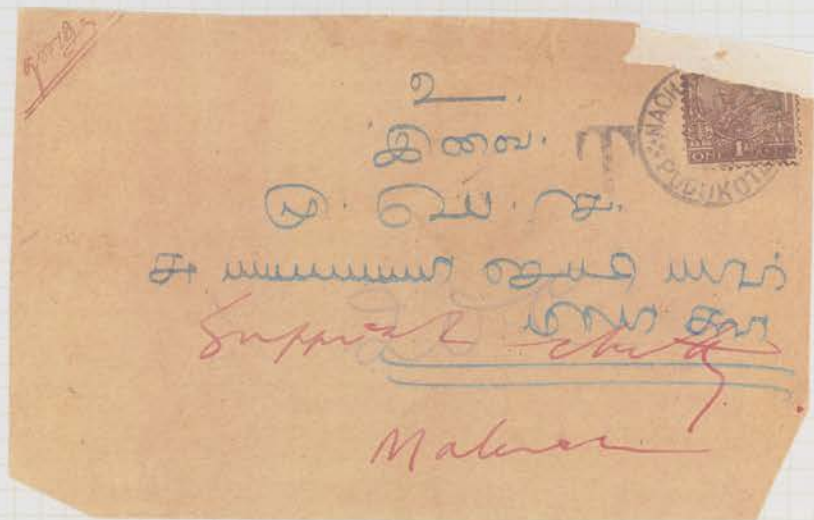


MALAYA – STRAITS SETTLEMENTS

Malacca

1922?

Underpaid letter from Nachanoupatti, Pudukotah, India to Malacca, Straits Settlements, Malaya partly paid by a copy of the 1 Anna of 1922 (SG197). The rate was 2 Annas and the deficiency 1 Anna. Also on the obverse is an Indian "T" (Taxe) mark together with a manuscript "20c" to indicate double the deficiency in gold centimes. On the reverse there is a Malacca arrival mark and a postage due mark "Malacca/ to pay/ 8 cts." indicating that postage due of 8 cents was charged.



MALAYA - STRAITS SETTLEMENTS

Singapore

January 1922

Underpaid letter from Shanmugana..., Ramnad, India to Singapore, Straits Settlements, Malaya postmarked 11 January 1922 on the reverse on a copy of the 1 Anna of 1911. The rate was 2 Annas and the deficiency 1 Anna.

On the obverse are Indian "T" (Taxe) and semi-circular "Shanmugana.../ due/ Anna" marks. On the reverse is a Singapore arrival mark of 20 January 1922 and a boxed "Singapore/ to pay 8 cents" mark indicating that postage due of 8 cents was charged.



MALAYA – STRAITS SETTLEMENTS

Penang

January 1922

Indian KGV PSE (old internal rate of ½ Anna) to Penang, Straits Settlements, Malaya postmarked 16 JAN 22. The rate was 2 Annas and the deficiency 1½ Annas. There is an Indian "T" (Taxe) mark as well as a manuscript "30c" to denote double the deficiency in gold centimes. On the reverse there is a Penang arrival mark of 27 JA 1922 as well as a boxed postage due mark "To Pay/ 10 cents" indicating that postage due of 10 cents was charged.



MALAYA - STRAITS SETTLEMENTS

Penang

January/February 1922

Underpaid letter from Nachiyapuram, Ramnad, India to Penang, Straits Settlements, Malaya postmarked 24 JAN 22 on the reverse on a marginal copy of the 1½ Annas of 1919.

The rate was 2 Annas and the deficiency ½ Anna.

On the obverse is an Indian "T" (Tax) mark. On the reverse there is an Indian transit mark of 24 JA 22. There is a Penang arrival mark of 1 FE 1922 and a boxed postage due mark "To pay/ 8 cents" indicating that postage due of 8 cents was charged.

MALAYA - STRAITS SETTLEMENTS

Malacca

February 1922

Underpaid Indian KGV PSC (old local rate of ¼ Anna) from Bombay, India to Malacca, Straits Settlements, Malaya postmarked 16 February 1922 partly uprated with a copy of the 9 pies on 1 Anna of 1921. The rate was 1½ Annas and the deficiency was ½ Anna.

There is an Indian "T" (Tax) mark and a red manuscript "30c" to denote double the deficiency in Gold centimes. The postage due was indicated by a boxed "Malacca/ To pay 8 cents" and a red manuscript "8". There is an arrival mark of Malacca of 2 March 1922 on the reverse. The item was refused which is so marked in red manuscript on the face. The item was then sent to the Dead Letter Office in Malacca where it received a transit mark of 6 March 1922 before being returned to Bombay where it then received a DLO/ Bombay mark of 24 March 1922.

MALAYA - STRAITS SETTLEMENTS

Singapore

December 1919/ March 1922

Underpaid letter from England initially to Shanghai, China postmarked 9 DE 19 on a strip of three copies of the 1/2d of 1913. The rate was 2 1/2d and the deficiency 1d.

On the obverse is a London "T/20/L" (Taxe) mark in a hexagon denoting double the deficiency in French centimes. The letter was unclaimed and eventually firstly redirected over a year later in red to Mandalay, Burma with, on the reverse, transit marks of Hong Kong of 16 MAR 21 and Shanghai of MR 19 and 21/21 but not before receiving an "8 cents" postage due mark in red possibly in Hong Kong. Delivery in Burma did not prove possible either and the letter was further secondly redirected to Tanglin, Singapore, Malaya. There is an arrival mark of Tanglin of 19 MR 1922 a year after leaving Shanghai. A boxed Singapore postage due mark "Singapore/ To pay 8 cents" indicating that postage due of 8 cents was chargeable. Again, delivery was not possible and the letter was redirected yet again to a fourth destination (again in Burma?) with a delivery mark of 29 MAR 22.

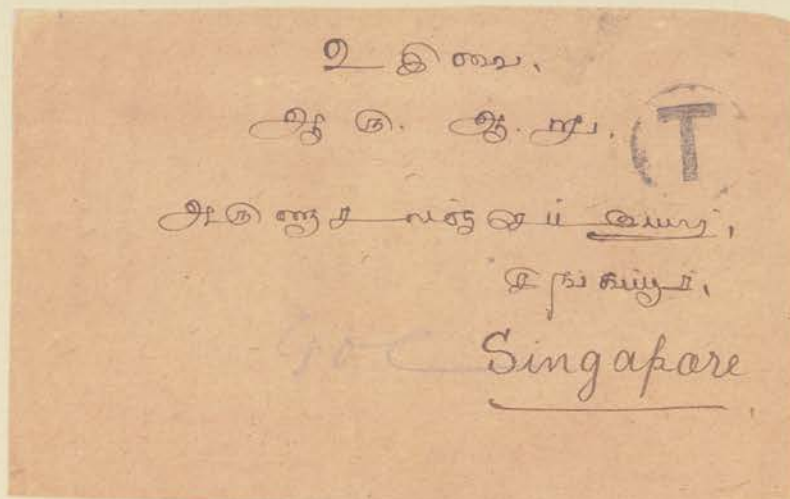


MALAYA - STRAITS SETTLEMENTS

Singapore

March/April 1922

Underpaid letter from Padan, India to Singapore, Straits Settlements, Malaya postmarked 9 MAR 22 on the reverse on a copy of the 1 Anna of 1911. The rate was 2 Annas and the deficiency 1 Anna. On the obverse is an Indian "T" (Taxe) mark and a manuscript "40c" to indicate double the deficiency in gold centimes. On the reverse there is a Singapore arrival mark of 3 AP 1922 and a red postage due mark "Singapore/ To pay 8 cents" indicating that postage due of 8 cents was charged.



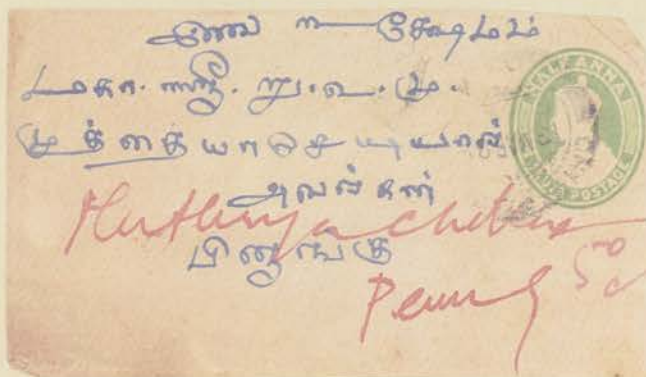
MALAYA – STRAITS SETTLEMENTS

Penang

March 1922

Indian KGV PSE (old internal rate of ½ Anna) to Penang, Straits Settlements, Malaya postmarked 13 MAR 22. The rate was 2 Annas and the deficiency 1½ Annas.

On the obverse there is a red manuscript "50c" to indicate double the deficiency in gold centimes. On the reverse there is a Penang arrival mark of 24 MR 1922 indicating a transit time of 11 days and a boxed postage due mark "To Pay/ 10 cents" indicating that postage due of 10 cents was charged.



MALAYA - STRAITS SETTLEMENTS

Singapore

June 1922

Unpaid letter from Karaikudi, India to Singapore, Straits Settlements, Malaya postmarked 4 June 1922. The rate was 2 Annas and the deficiency 1 Anna. On the obverse there is an Indian "T" (Taxe) mark and a semi circular "Karaikudi/ Due/ As" domestic mark.

On the reverse there is a Singapore arrival mark 14 July 1922 indicating a transit period of 10 days and a boxed postage due mark "Singapore/ To Pay 12 cents" indicating that 12 cents was charged.
