

# MALAYA – STRAITS SETTLEMENTS

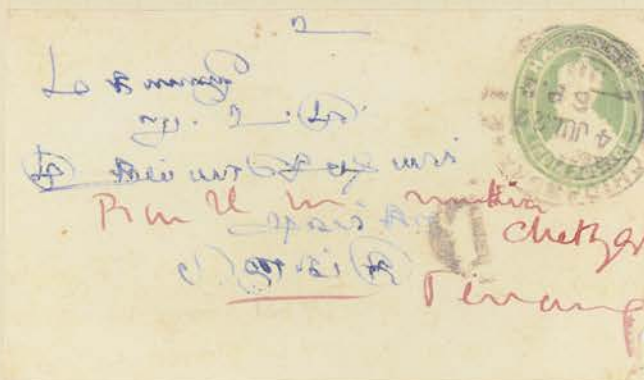
## Penang

July 1922

Indian KGV PSE (old internal rate of ½ Anna) from Chidaddaram, India to Penang, Straits Settlements, Malaya partly uprated with a copy of the ½ Anna of 1912 on the reverse both postmarked 4 JUL 22.

The rate was 2 Annas and the deficiency 1 Anna

On the obverse there is an Indian "T" (Taxe) mark and on the reverse a red manuscript "40c" to denote double the deficiency in gold centimes. Also on the reverse there is a Penang arrival mark of 14 JY 1922 and a boxed Penang postage due mark "To Pay/ 8 cents" indicating that postage due of 8 cents was charged.



# MALAYA – STRAITS SETTLEMENTS

## Singapore

July 1922

Underpaid letter from India to Singapore, Straits Settlements, Malaya postmarked 8 JUL 22 on a horizontal pair of the ½ Anna of 1912 on the reverse. The rate was 2 Annas and the deficiency 1 Anna. Also on the reverse is a manuscript "40c" to denote double the deficiency in gold centimes. There is also a Singapore arrival mark of 17 JY 1922 and a red boxed postage due mark "Singapore/ To pay 8 cents" indicating that postage due of 8 cents was charged.

## MALAYA - STRAITS SETTLEMENTS

### Malacca via Singapore

July/August 1922

Underpaid letter from Kwangchow to Malacca, Straits Settlements, Malaya postmarked 22 - 7 22 on four copies of the 4 cents on 10 centimes of 1919. The rate was 20 cents and the deficiency 4 cents. There is a "T" (Taxe) mark in an inverted triangle of the French Leased Territory. There is a Singapore transit mark of ?AU 1922 and a Malacca arrival mark of 9 AU 1922. There is also a boxed "Malacca/ to pay/ 8 cents" to show double the deficiency charged. There is a previously unrecorded Malacca boxed "Refuse/ Refused" and a mark of 13 AU 1922 of the Malacca Dead Letter Office in red.



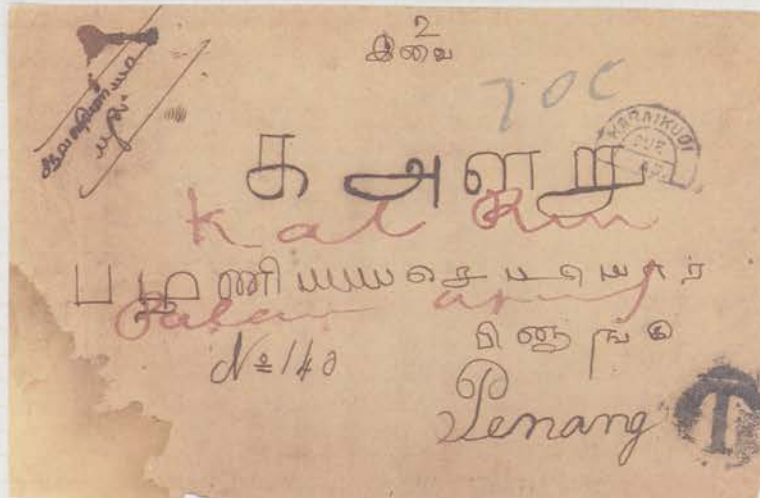
# MALAYA – STRAITS SETTLEMENTS

Penang

July/August 1922

Unpaid letter from Karaikudi, India to Penang, Straits Settlements, Malaya postmarked 22 JUL 22 on the reverse. The rate, and the deficiency, was 2 Annas.

On the obverse there is a "T" (taxe) mark, a semi circular "Karaikudi/ due/ ...As" and a manuscript "20" to indicate double the deficiency in gold centimes. On the reverse there is a Penang arrival mark of 3 AU 1922 and boxed postage due mark "To pay/ 12 cents" indicating that postage due of 12 cents was charged.

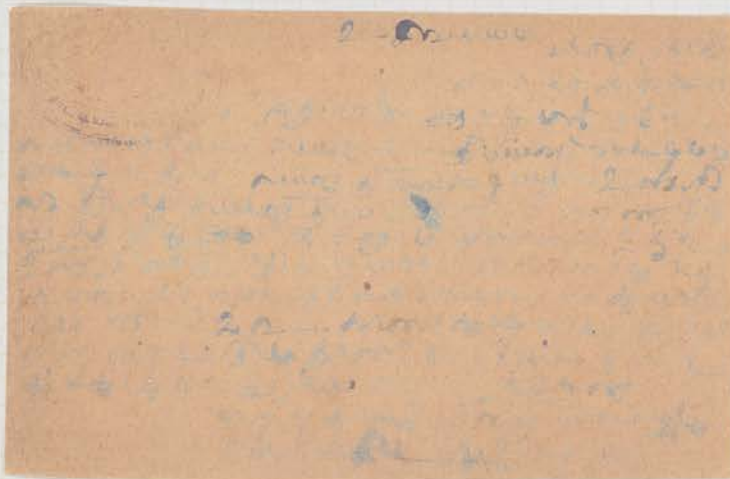


# MALAYA – STRAITS SETTLEMENTS

## Penang

July/August 1922

Underpaid internal (¼ Anna) PSC from India to Penang, Straits Settlements, Malaya partly uprated with a copy of the 3 pies of 1911 postmarked 29 JULY 22. The rate was 1½ Annas and the deficiency 1 Anna. Also on the obverse is an Indian "T" (Taxe) mark. There is also a Penang arrival mark of 10 AU 1922 and a boxed postage due mark "To pay/ 8 cents" indicating that postage due of 8 cents was charged.





# MALAYA - STRAITS SETTLEMENTS

Singapore

September/October 1922

Unpaid letter from Kahaikudi, India to Singapore, Straits Settlements, Malaya postmarked 25 SEP 22 on the reverse. The rate, and the deficiency, was 2 Annas.

On the obverse is an Indian "T" (Tax) mark over a blue manuscript "40c" denoting double the deficiency in gold centimes and a semi-circular "Kahaikudi/ Due/ As." mark.

On the reverse there is a Singapore arrival mark of 8 October 1922 and a faint red postage due mark "Singapore/ To pay/ 10 cents" indicating that postage due of 10 cents was charged.



# MALAYA - STRAITS SETTLEMENTS

Penang

October 1922

Unpaid letter from Kanadukathan, India to Penang, Straits Settlements, Malaya postmarked 4 OCT 22 on the reverse. The rate, and deficiency, was 2 Annas.

On the obverse is an Indian "T" (Taxe) mark, a manuscript "40c" to denote double the deficiency in gold centimes and a semi-circular "Kanadukathan/ Due/ As." postage due mark. On the reverse there is a transit mark of Nachiyapuram, Ramnad of 4 OCT 22. There is a Penang arrival mark of 16 OC 1922 and a boxed postage due mark "To pay/ 10 cents" indicating that postage due of 10 cents was charged.





# MALAYA – STRAITS SETTLEMENTS

## Singapore

November 1922

Unpaid letter from ...iyapuram, Ramnad, India to Singapore, Straits Settlements, Malaya postmarked on the reverse 13 November 1922. There is also a transit marking of Kanad(uk)athan on the same day.

The rate, and the deficiency, was 2 Annas.

On the obverse there is an Indian "T" (Taxe) mark and a manuscript "40c" to denote double the deficiency in gold centimes. On the reverse there is a Singapore arrival mark of 30 November 1922 and a boxed postage due mark "Singapore/ to pay/ 10 cents" in red indicating that postage due of 10 cents was charged.



# MALAYA - STRAITS SETTLEMENTS

Singapore

December 1922

Unpaid letter from Pudukotam-Trichinopoly, India to Singapore, Straits Settlements, Malaya postmarked 8 December 1922 on the reverse. The rate and the deficiency was 2 Annas.

On the obverse there is an Indian "T" (Taxe) mark and a blue manuscript "40c" to denote double the deficiency in gold centimes as well as a domestic "Pudukotam-Trichinopoly/ Due/ As" applied in error. On the reverse there is a Singapore arrival mark of 17 December 1922 as well as a red "Singapore/ To pay/ 10 cents" mark showing the postage due.
