

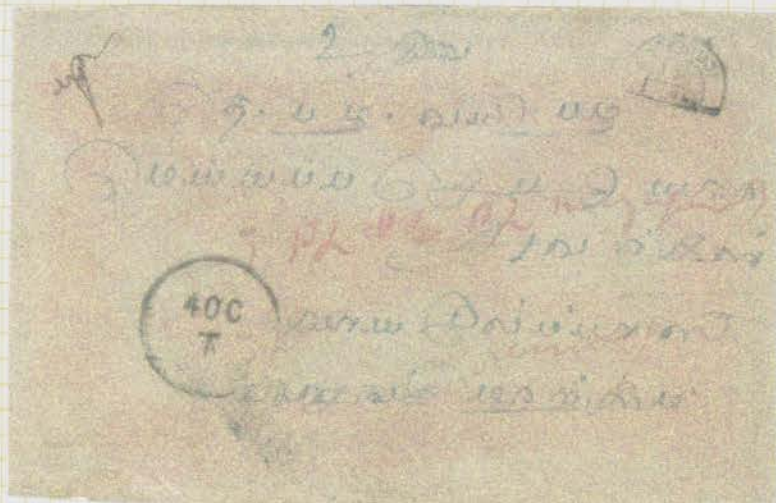
MALAYA – STRAITS SETTLEMENTS

Penang

October 1926

Unpaid letter from Karaikudi, India to Penang, Straits Settlements, Malaya postmarked 21 OCT 26 on the reverse. The correct rate, and the deficiency, was 2 Annas.

On the obverse there is an Indian "40C/ T" (Taxe) mark in a circle indicating double the deficiency in gold centimes as well as a semi-circular "Karaikudi/ Due/ As" mark. There is an arrival mark of Penang of 29 OC 1926 on the reverse on a copy of the 12 cents postage due stamp of 1924.



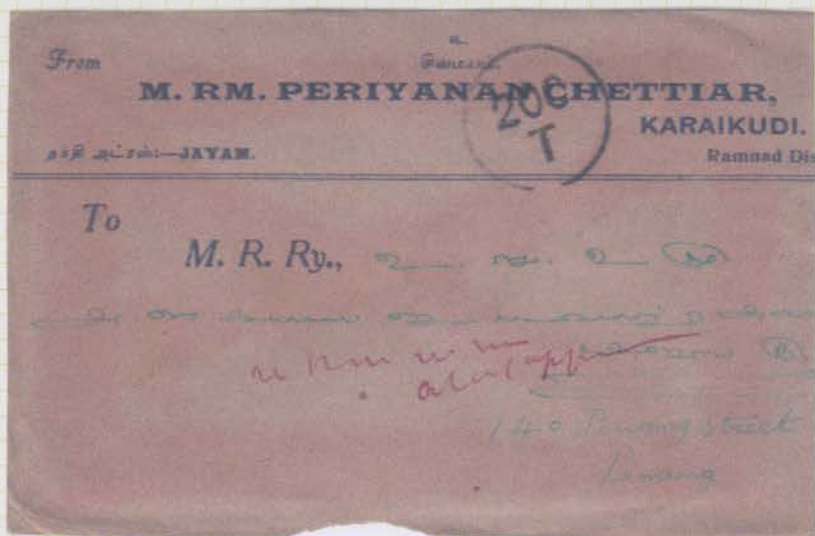
MALAYA – STRAITS SETTLEMENTS

Penang

November 1926

Underpaid letter from Karaikudi, India to Penang, Straits Settlements, Malaya partly paid on the reverse by a copy of the 1 Anna of 1922 postmarked 13 NOV 26. The rate was 2 Annas and the deficiency 1 Anna.

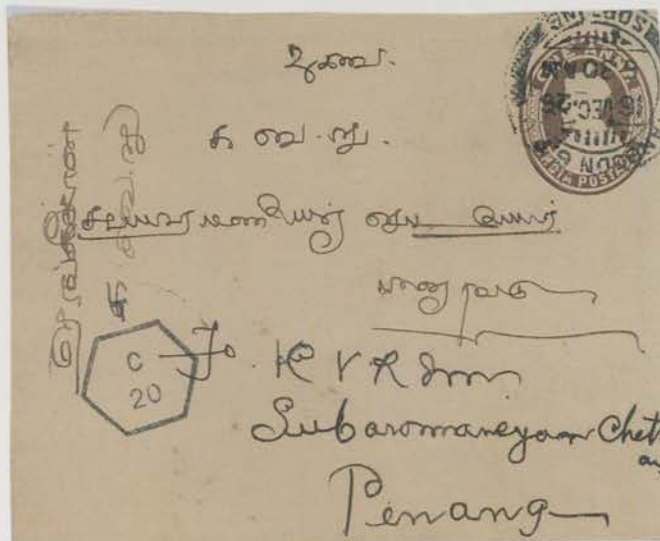
On the obverse is an Indian "20C/T" (Tax) mark in a circle indicating double the deficiency in gold centimes. The arrival mark of Penang of 25 NO 1926 is on the reverse on a copy of the 8 cents postage due stamp of 1924.



Penang

December 1926

Indian KGV PSE (local rate of 1 Anna) from Rangoon, Burma (then using Indian stamps) to Penang, Straits Settlements, Malaya partly postmarked 16 December 1926. The rate was 2 Annas, the deficiency 1 Anna. On the obverse is a Burmese "T/ C/ 20" (Taxe) mark in a pentagon indicating double the deficiency in gold centimes. On the reverse the arrival mark of Penang of 20 December 1926 is on a copy of the 8 cents postage due stamp of 1924.



MALAYA - STRAITS SETTLEMENTS

Penang and Singapore

December 1926/ January 1927

Underpaid letter from Calcutta, India to Singapore, Straits Settlements, Malaya partly paid by a copy of the 1 Anna of 1922 postmarked 28 December 1926. The rate was 2 Annas and the deficiency was 1 Anna. On the obverse there is an Indian "T" (Taxe) mark and a pencilled "20c" indicating double the deficiency in gold centimes. The arrival mark of Singapore is 6 January 1927 and is on a copy of the 8 cents postage due stamp of 1924. The addressee was in Penang so the stamp was cancelled and the letter was redirected there. In Penang a further copy of the 8 cents postage due stamp was applied but this time on the reverse cancelled 14 January 1927. The addressee had left Penang to return to Singapore so a 4 cent stamp of 1913 was applied on the obverse postmarked 15 January.



MALAYA - STRAITS SETTLEMENTS

Singapore

January/February 1927

Unpaid letter from Melur Madura, India to Singapore, Straits Settlements, Malaya postmarked 25 JAN.27 on the reverse. The rate, and the deficiency, was 2 Annas.

On the obverse is an Indian "40C/ T" (Taxe) mark indicating double the deficiency in gold centimes and a semi-circular "Melur Madura/ Due/...As". On the reverse the arrival mark of Singapore of 7 FE 1927 is on a copy of the 12 cents postage due stamp of 1924.

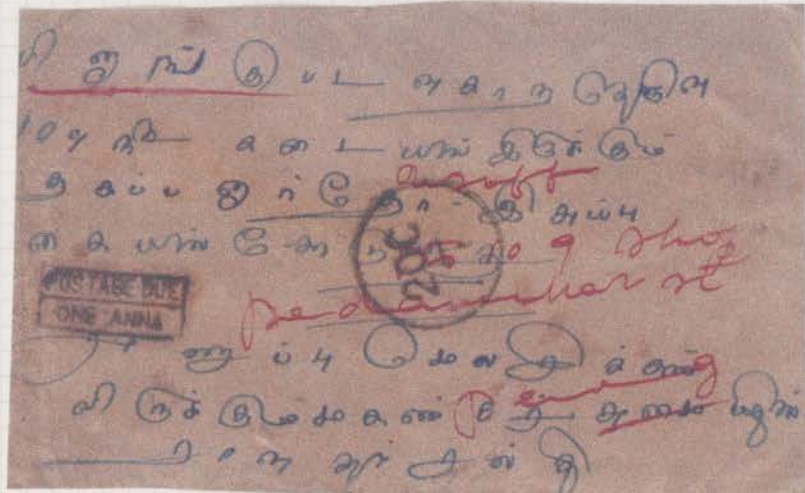


MALAYA - STRAITS SETTLEMENTS

Penang

March 1927

Underpaid letter from Experimental PO M-99, India to Penang, Straits Settlements, Malaya postmarked 15 MAR.27 on a copy of the 1 Anna of 1926. The rate was 2 Annas and the deficiency was 1 Anna. On the obverse is an Indian "20C/T" (Tax) mark in a circle indicating double the deficiency in gold centimes and a boxed "Postage Due/ One Anna". The arrival mark of Penang of 28 MR 1927 is on a copy of the 8 cents postage due stamp of 1924.

Penang

April 1927

Unpaid letter from Karaikudi, India to Penang, Straits Settlements, Malaya postmarked 14 APR 27 on the reverse. The rate, and the deficiency, was 2 Annas.
On the obverse is an Indian "40C/ T" (Taxe) mark indicating double the deficiency in gold centimes.
On the reverse the arrival mark of Penang of 22 AP 1927 is on a copy of the 12 cents postage due stamp of 1924.
