

# MALAYA - FEDERATED MALAY STATES

Negri Sembilan

August 1920

Underpaid letter from Pudumotan, India to Seremban, Negri Sembilan, Malaya postmarked 10 AUG 20 on a copy of the 1 Anna of 1911. The rate was 1½ Annas and the deficiency ½ Anna.

Also on the obverse is an Indian "T" (Taxe) mark.

On the reverse there is a transit mark of Foreign Post, Negapatam, India of 12 AU 20 as well as a Seremban arrival mark of 19 AU 1920. On the obverse there is a Seremban postage due mark "T/SBN 4 cents/to pay" indicating that postage due of 4 cents was charged.



## MALAYA - FEDERATED MALAY STATES

### Negri Sembilan

August 1920

Indian KGV Postal Stationary envelope (old internal rate of ½ Anna) to Seremban, Negri Sembilan, Malaya postmarked on the obverse is 17 AUG 20. The rate was 1½ Annas and the deficiency 1 Anna.

Also on the obverse is an Indian "T" (Taxe) mark.

On the reverse there is a Seremban arrival mark of 29 AU 1920. On the obverse there is a Seremban postage due mark "T/SBN 8 cents/to pay" indicating that postage due of 8 cents was charged.





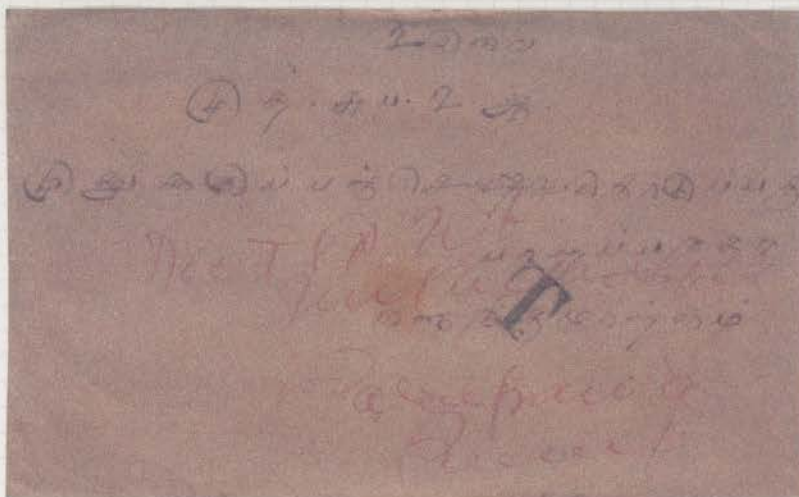
# MALAYA - FEDERATED MALAY STATES

Perak

August/September 1920

Underpaid envelope from Paganeri, Ramnad, India to Parit Buntar, Perak, Malaya. The rate was 1½ Annas and the underpayment 1 Anna.

On the obverse there is an Indian "T" (Taxe) mark. On the reverse are a transit mark of 2 SE 1920 and a boxed postage due mark "T cents 4" of Taiping. The Parit Buntar arrival mark is 3 SE 1920.



# MALAYA - FEDERATED MALAY STATES

Selangor

September 1920

Underpaid letter card from Ilfracombe, England to Kuala Lumpur, Federated Malay States, Malaya with postage partly paid by a copy of the 1d of 1912 postmarked 4 September 1920.

The rate was 2d and the deficiency 1d.

There is a London "T/ 20/ L" (Taxe) mark denoting double the deficiency in French centimes. The arrival mark is a large blue manuscript "8" indicating that postage due of 8 cents was charged.

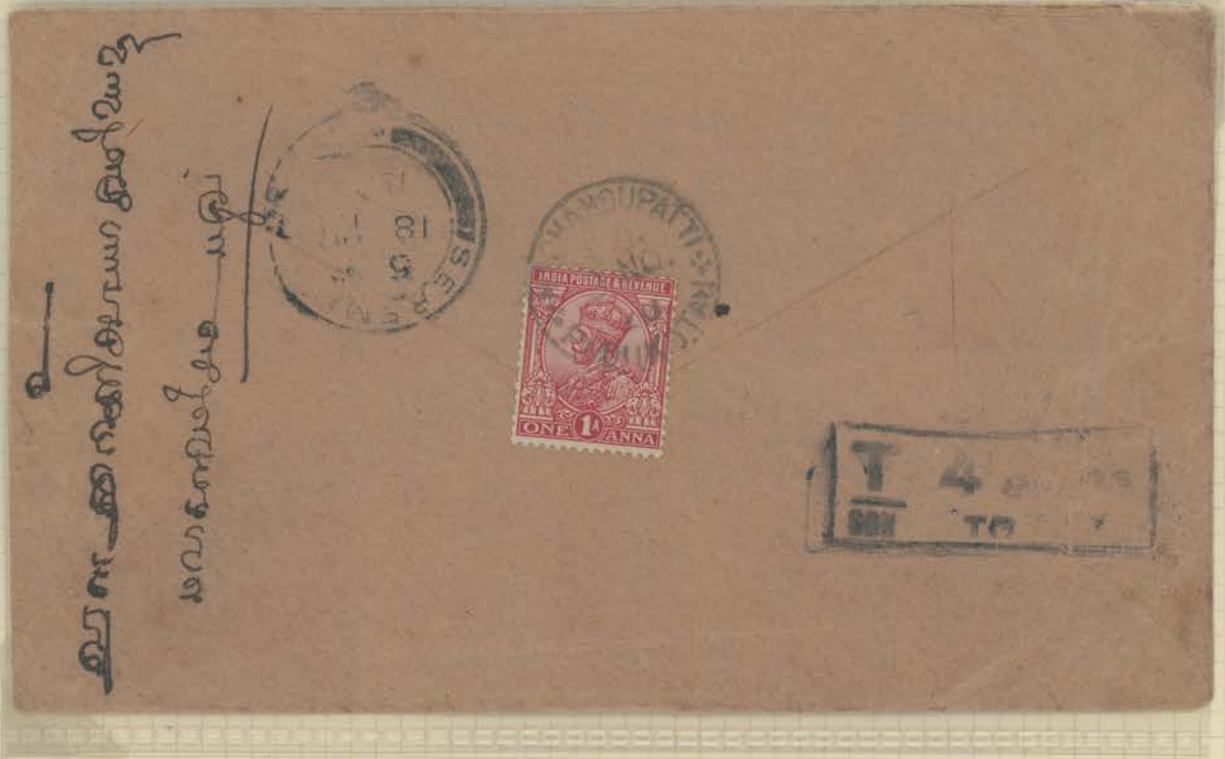
Negri Sembilan

November 1920

Underpaid letter from Kaomanoupatti, Pudukotah, India to Seremban, Negri Sembilan, Malaya postmarked on the reverse 8 NO 20 on a copy of the 1 Anna of 1911.

The rate was 1½ Annas and the deficiency ½ Anna.

On the obverse is an Indian "T" (Taxe) mark. On the reverse there is a Seremban arrival mark of 18 NO 1920. Also on the obverse there is a Seremban postage due mark "T/SBN 4 cents/to pay" indicating that postage due of 4 cents was charged.







# MALAYA - FEDERATED MALAY STATES

Perak

December 1920

Indian KGV Postal Stationary envelope (old internal rate of ½ Anna) from Tirrevelly Town, India to Ipoh, Perak, Malaya partly uprated on the reverse with a copy of ½ Anna of 1912 postmarked 15 DEC 20.

The rate was 1½ Annas and the deficiency was ½ Anna.

There is an Indian "T" (Taxe) mark on the obverse as well as a manuscript "20c" (which has been deleted) to incorrectly indicate double the deficiency in French centimes. On the reverse there is an Ipoh arrival mark of 24 DE 1920 and a circular "T/ 4 CTS" mark to indicate postage due of 4 cents was charged.



# MALAYA - FEDERATED MALAY STATES

Perak

December 1920/January 1921

Underpaid letter from India addressed to Kampar, Perak, Malaya postmarked on the reverse 31 DEC 20 on two copies of the ½ Anna of 1912. The rate was 1½ Annas and the deficiency ½ Anna. On the obverse is an Indian "T" (Taxe) mark and a large pencilled "4" on the obverse and, on the reverse, a red manuscript "10c" being double the deficiency in French centimes. On the reverse there is an Ipoh transit mark of 12 JA 1921 and a postage due mark "T/ 4 Cts" in a circle indicating that postage due of 4 cents was charged. There is no Kampar arrival mark.
