

# MALAYA - FEDERATED MALAY STATES

Negri Sembilan

January 1921

Underpaid letter from Pattalam, Ceylon to Seremban, Negri Sembilan, Malaya postmarked 17 JA 21 on a copy of the 6 cents of 1912. The rate was 9 cents and the deficiency 3 cents.

On the obverse is a Ceylon "T" (Taxe) mark next to a pencilled "10c" to indicate double the deficiency in French centimes and a Seremban postage due mark "T/SBN 4 cents/to pay" indicating that postage due of 4 cents was charged. On the reverse is a Seremban arrival mark of 26 JA 1921.

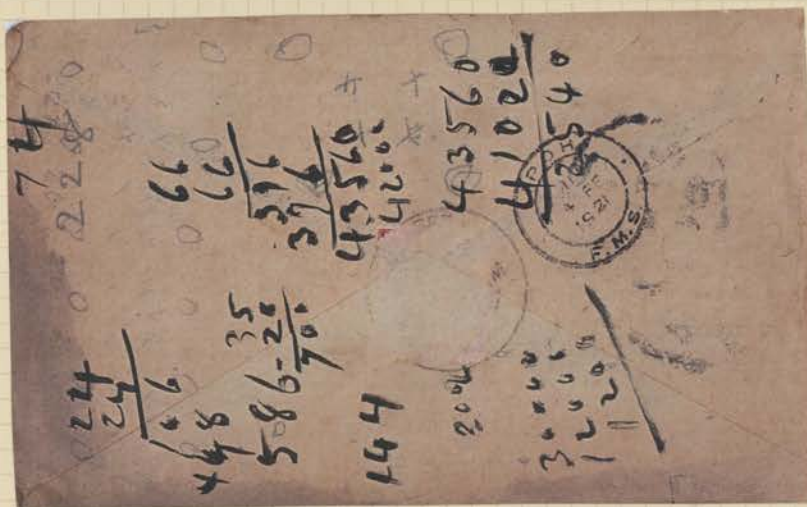


# MALAYA - FEDERATED MALAY STATES

Perak

January/February 1921

Underpaid letter from India to Ipoh, Perak, Malaya partly paid with a missing 1 Anna stamp on the reverse. The rate was 1½ Annas and the deficiency ½ Anna. On the obverse there is an Indian "T" (tax) mark. The Ipoh arrival mark on the obverse and reverse is 4 FE 1921. Also on the obverse is a Ipoh postage due mark "T/ 4 CTS" in a circle indicating that postage due of 4 cents was charged.





# MALAYA - FEDERATED MALAY STATES

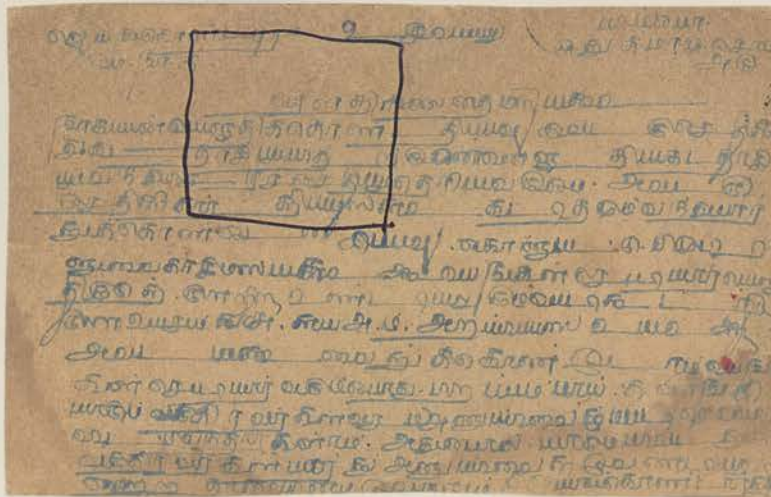
Perak

January/February 1921

Underpaid Indian PSC (old internal rate  $\frac{1}{4}$  Anna) from Karaikudi, India to Ipoh, Perak, Malaya partly uprated with a  $\frac{1}{2}$  Anna of 1911 postmarked 31 January 1921.

The rate was 1 Anna, the deficiency  $\frac{1}{4}$  Anna.

There is an Indian "T" (taxe) mark next to a manuscript "5c" to indicate double the deficiency in French centimes. The Ipoh arrival mark is 17 February 1921 and there is a Ipoh postage due mark "T/ 2 Cts" in a circle indicating that postage due of 2 cents was charged.





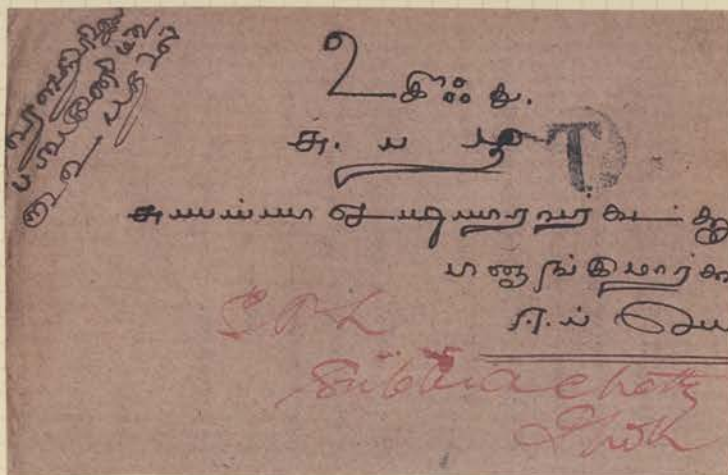


# MALAYA - FEDERATED MALAY STATES

Perak

February/March 1921

Underpaid letter from Konapet, India to Ipoh, Perak, Malaya partly paid with a 1 Anna of 1911 postmarked 27 FE 21 on the reverse. The rate was  $1\frac{1}{2}$  Annas and the deficiency  $\frac{1}{2}$  Anna. On the obverse there is an Indian "T" (tax) mark and, on the reverse, a red manuscript "10c" to denote 10 gold centimes. Also on the reverse there is an Ipoh arrival mark of 14 MR 1921 and a feint "T/ 4 CTS" mark in a circle indicating that postage due of 4 cents was charged.



# MALAYA - FEDERATED MALAY STATES

Perak via Selangor

February 1921

Indian KGV Postal Stationary envelope (old internal rate of ½ Anna) from Poolancuruchy, Ramnad, India to Taiping, Perak, Malaya partly uprated on the reverse by a copy of ½ Anna of 1912 postmarked 16 FE 21 in the Foreign Post Branch, Negapatam on the reverse.

The rate was 1½ Annas and the deficiency ½ Anna.

There is an Indian "T" (Taxe) mark on the obverse. On the reverse there is a Kuala Lumpur transit mark of 23 FE 1921 and a "4" tax mark. There is a Taiping arrival mark of 24 FE 1921.





# MALAYA - FEDERATED MALAY STATES

Negri Sembilan

March 1921

Unpaid letter from Nachanoupatti, Pudukotah, India to Seremban, Negri Sembilan, Malaya postmarked on the reverse 20 MA 21. The rate, and the deficiency, was 1½ Annas. On the obverse is an Indian "T" (Taxe) marking in a circle and a boxed "T/SBN ... cents/to pay" mark with a manuscript "12" inserted indicating that postage due of 12 cents was charged. On the reverse there is a Seremban arrival mark of 31 MR 1921.



# MALAYA - FEDERATED MALAY STATES

Perak

March/April 1921

Underpaid letter from India to Ipoh, Perak, Malaya postmarked on the reverse 30 March 1921 on a copy of the 1 Anna of 1912. The rate was  $1\frac{1}{2}$  Annas and the deficiency  $\frac{1}{2}$  Anna. On the obverse is an Indian "T" (Tax) mark. On the reverse is an Ipoh arrival mark of April 1921 and a boxed rectangular mark "T cents 4" to indicate that postage due of 4 cents was charged.
