

# MALAYA - FEDERATED MALAY STATES

Perak

April 1922

Indian KGV PSE (old internal rate of ½ Anna) from Tinnevelly, India to Ipoh, Perak, Malaya postmarked 17 APR 22 and on a copy of the ½ Anna of 1912 on the reverse.

The rate was 2 Annas and the deficiency 1 Anna

On the obverse is an Indian "T" (Taxe) mark together with a manuscript "40c" to denote double the deficiency in gold centimes. Also on the obverse is an Ipoh postage due mark "T cents 11" indicating that postage due of 11 cents was raised. On the reverse there is an Ipoh arrival mark of 28 AP 1922.

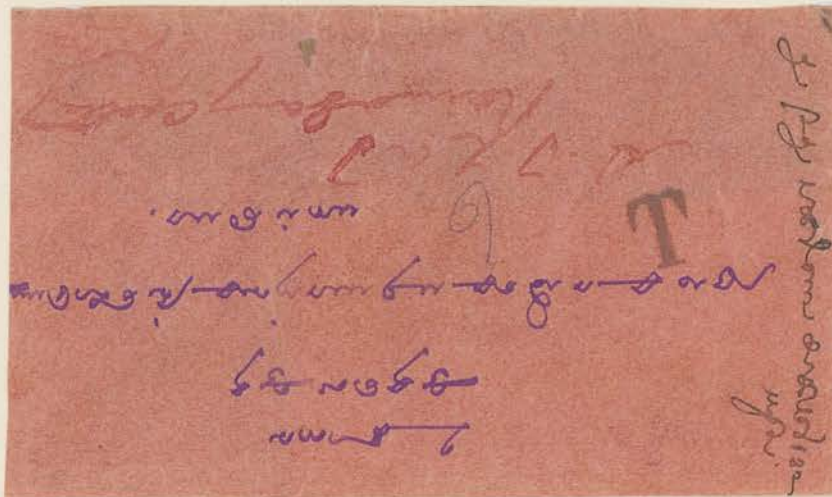


# MALAYA - FEDERATED MALAY STATES

Perak

May 1922

Unpaid letter from Kottaiyur, India to Ipoh, Perak, Malaya postmarked 12 May 1922 on the reverse. The rate, and deficiency, was 2 Annas. On the obverse is an Indian "T" (Taxe) mark. On the reverse there is an Ipoh arrival mark of 18 May 1922 indicating a transit period of 6 days and a "T cents 16" mark indicating that postage due of 16 cents was charged. .



# MALAYA - FEDERATED MALAY STATES

Perak

May 1922

Underpaid letter from Manaohanallur, Trichinopoly, India to Kampar, Perak, Malaya postmarked 15 May 1922 on a copy of the 1 Anna of 1911. The rate was 2 Annas and deficiency 1 Anna. There is also an Indian "T" (Taxe) mark, a manuscript "40c" to indicate double the deficiency in gold centimes and a blue manuscript "11" on the obverse.

On the reverse there is an Ipoh transit mark of 28 May 1922 and a Kampar arrival mark of 30 May 1922 and an Ipoh small "T cents 11" rectangular mark indicating that postage due of 11 cents was charged.

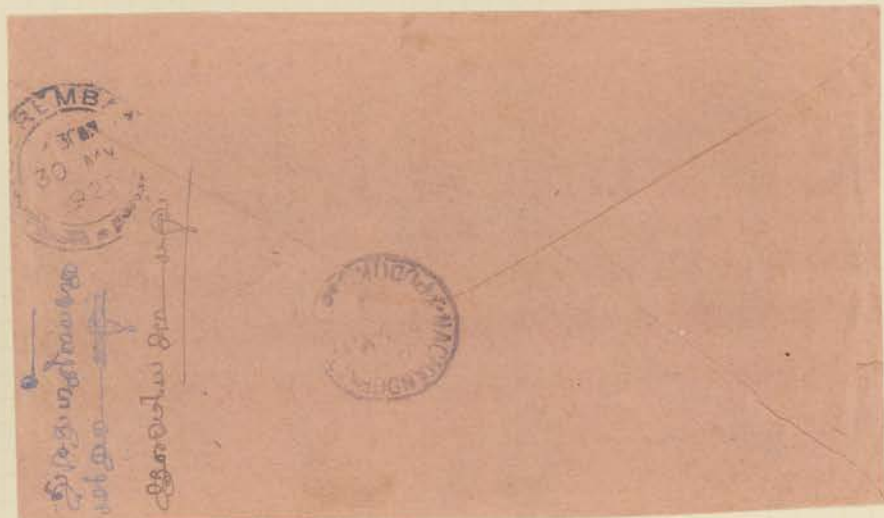
Negri Sembilan

May 1922

Unpaid letter from Kaohanoupatti, Pudukotah, India to Seremban, Negri Sembilan, Malaya postmarked 20 May 1922 on the reverse. The rate, and deficiency, was 2 Annas.

There is an Indian "T" (Taxe) mark and a Seremban postage due mark "Seremban/ 16 cts./ to pay" in purple indicating that postage due of 16 cents was charged on the obverse.

On the reverse there is a Seremban arrival mark of 30 May 1922.



Underpaid letter from Kumbakonam Bazar, India to Kampar, Perak, Malaya postmarked 21 May 1922 on a copy of the 1 Anna of 1911 on the reverse. The rate was 2 Annas and deficiency 1 Anna.

On the obverse is an Indian "T" (Taxe) mark and a blue manuscript "11".

On the reverse there is an Ipoh transit mark of 2 June 1922 and a small rectangular "T cents 11" mark indicating that postage due of 11 cents was charged. There is an arrival mark of Kampar of 3 June 1922.

Underpaid letter from Rangoon, Burma to Gopeng, Perak, Malaya postmarked 21 July 1922 on a copy of the Indian 1 Anna of 1911 on the reverse. The rate was 2 Annas and the deficiency 1 Anna.

On the obverse there is a "T" (taxe) mark.

On the reverse there is are transit marks of 28 July 1922 of Penang and Ipoh and a Gopeng arrival mark of 29 July 1922. There is also a "T cents 11" Ipoh boxed postage due mark indicating that postage due of 11 cents was charged.

Underpaid letter from India to Ipoh, Perak, Malaya postmarked 27 July 1922 on a copy of the 1 Anna of 1911 on the reverse. The rate was 2 Annas and the deficiency 1 Anna. On the obverse there is an Indian "T" (taxe) mark.

On the reverse there is an Indian "Late Fee/ Not paid/ Detained" mark. There is also a Ipoh arrival mark of 12 August 1922 and a boxed Ipoh "T/ cents/ 11" postage due mark showing 11 cents was charged.

July/August 1922

Unpaid letter from Amaravathi-Pudur India to Ipoh, Perak, Malaya postmarked 27 July 1922 on the reverse. The rate, and the deficiency, was 2 Annas. On the obverse there is an Indian "T" (taxe) mark. On the reverse there is a Ipoh arrival mark of 13 August 1922 indicating a transit period of 17 days and a boxed Ipoh "T cents 16" postage due mark indicating that 16 cents was charged.

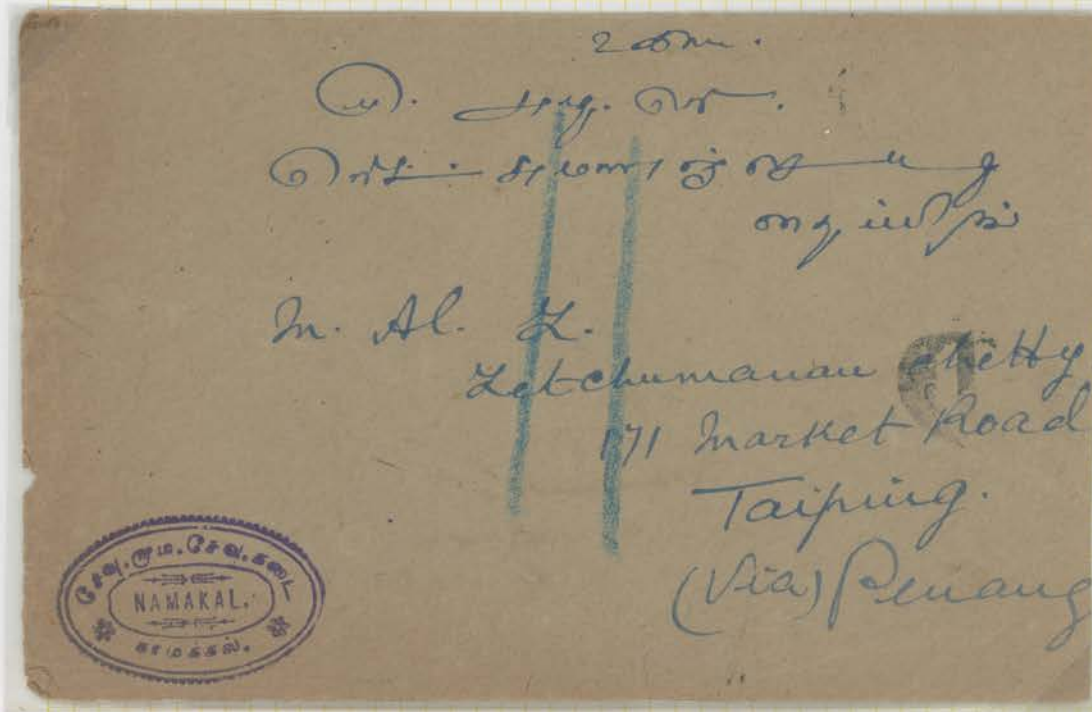

Perak

August 1922

Underpaid envelope from Namakkal, India to Taiping, Perak, Malaya postmarked 2 AUG.22 on the reverse on a copy of the 1 Anna of 1911. The rate was 2 Annas and the deficiency 1 Anna. On the obverse there is an Indian "T" (Taxe) mark. On the reverse there is a Taiping arrival mark of 28 AU 1922 and a manuscript "40C" to denote double the deficiency in gold centimes. Also on the obverse there is a large blue manuscript "11" to indicate the postage due in cents.



# MALAYA - FMS - STRAITS SETTLEMENTS

## Negri Sembilan/ Penang

August/September 1922

Indian KGV PSE (old internal letter rate of ½ Anna updated to 1 Anna) from India to Penang, Straits Settlements, by mistake initially via Seremban, Negri Sembilan, Malaya postmarked 27 AUG 22. The rate was 2 Annas and the deficiency 1 Anna. On the obverse there is an Indian "T" (Taxe) mark and a red manuscript "40c" to denote double the deficiency in gold centimes.

On the reverse there is firstly a Seremban arrival/transit mark of 9 SE 1922 and, on the obverse, a boxed "Seremban/ 11 Cts./ To Pay" mark.

On the reverse there is a Penang arrival mark of 13 SE 1922 and a boxed postage due mark "To Pay/ 12 cents" indicating that postage due of 12 cents was charged.



Underpaid letter from Kondanoor, India to Ipoh, Perak, Malaya postmarked 21 September 1922 on a copy of the 1/2 Anna of 1911. There is also an Indian "T" (Taxe) mark. The rate was 2 Annas and the deficiency 1 1/2 Annas.

On the reverse there is an Ipoh arrival mark of 28 September 1922 and a postage due mark "T cents 12" indicating that postage due of 12 cents was charged.
