

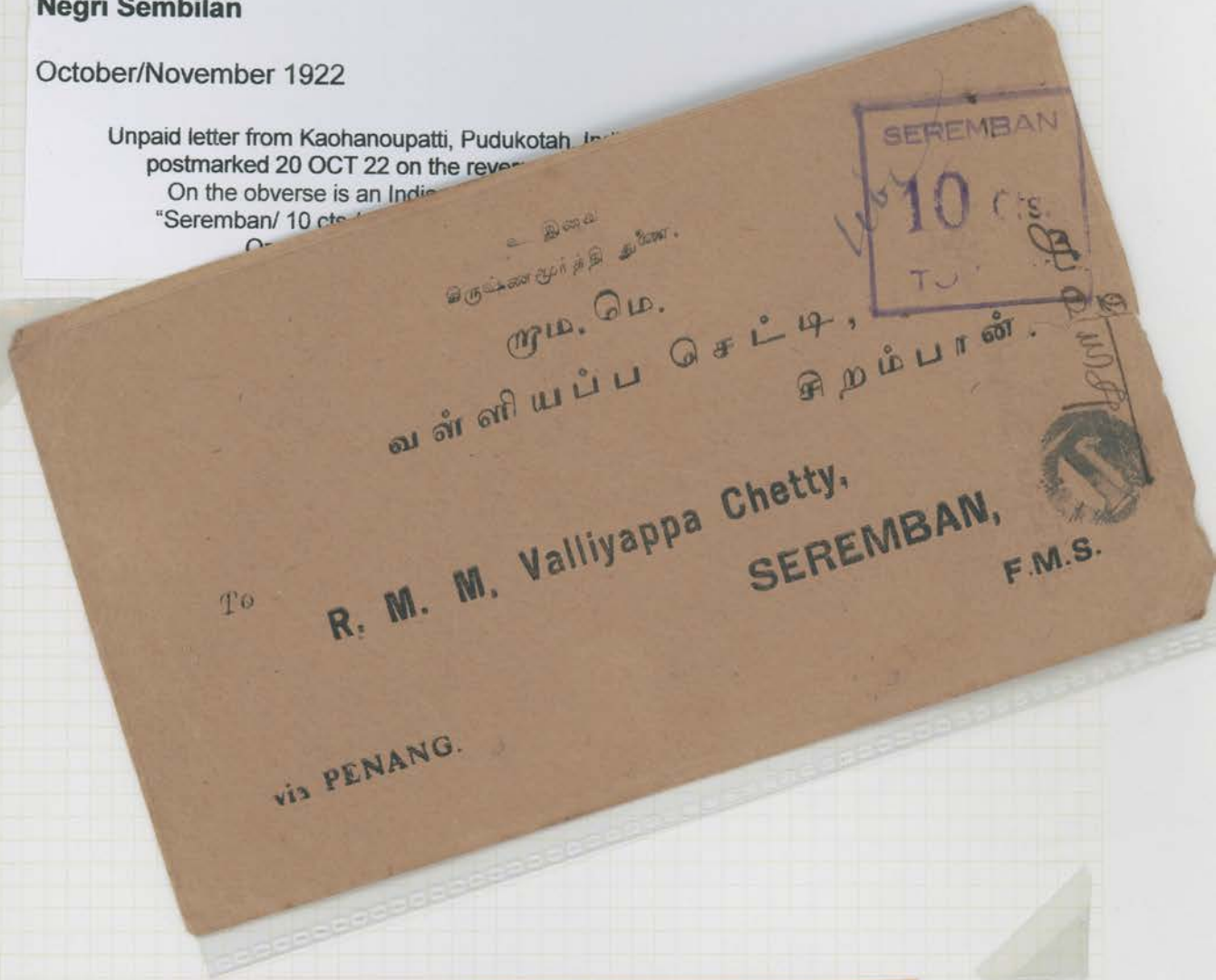
# MALAYA - FEDERATED MALAY STATES

Negri Sembilan

October/November 1922

Unpaid letter from Kaohanoupati, Pudukotah, India  
postmarked 20 OCT 22 on the reverse

On the obverse is an Indian  
"Seremban/ 10 cts" stamp



# MALAYA - FEDERATED MALAY STATES

Perak

November 1922

Indian KGV PSE (old internal rate of ½ Anna) from Devakottai, India to Kampar, Perak, Malaya postmarked 8 NO 22. The rate was 2 Annas and the deficiency 1½ Annas.

On the obverse is an Indian "T" (Tax) mark, a semi-circular "Devakottai/ due/ As" mark and an unknown postage due mark "Amount to be/ Collected ..." with a "6" inserted and then deleted in blue as well as a large blue manuscript "8". On the reverse is a Kampar arrival mark of 18 NO 1922 and an Ipoh boxed mark "T cents 8" applied in transit indicating that postage due of 8 cents was charged.



# MALAYA - FEDERATED MALAY STATES

Selangor

November/December 1922

Underpaid letter from Kottaiyur, India to Kuala Lumpur, Selangor, Malaya postmarked 13 NOV 22 on the reverse on a pair of the ½ Anna of 1911. The rate was 2 Annas and the deficiency 1 Anna. On the obverse is an Indian "T" (Taxe) mark. On the reverse is a manuscript "20c" mark to indicate double the deficiency in gold centimes as well as a Kuala Lumpur arrival mark of 3 DE 1922. On the obverse is a purple postage due mark "Kuala Lumpur/ 8 Cts./ To pay" indicating that postage due of 8 cents was charged.



# MALAYA - FEDERATED MALAY STATES

Perak

February/March 1923

Indian PSE (local rate of 1 Anna) from Rangoon, Burma to Taiping, Perak, Malaya postmarked 21 February 1923. The rate was 2 Annas and the deficiency 1 Anna. There is an Indian "T" (Taxe) mark and a manuscript "20c" mark to indicate double the deficiency in gold centimes.

On the reverse there is a Taiping arrival mark of 18 March 1923 and a boxed "Taiping/ 8 cts/ To pay" postage due mark indicating that postage due of 8 cents was charged.



# MALAYA - FEDERATED MALAY STATES

Perak

February/March 1923

Unpaid letter from Amaravathi Pudur, Ramnad, India to Ipoh, Perak, Malaya postmarked on the reverse 21 February 1923. The rate, and the deficiency, was 2 Annas. On the obverse is an Indian "T" (Tax) mark and a manuscript "40c" to indicate double the deficiency in gold centimes. There is also a transit mark of Karaikudi of 21 February 1923.

On the reverse there is an Ipoh arrival mark of 9 March 1923 and a boxed mark "Ipoh/ 10 cts/ To pay" indicating that postage due of 10 cents was charged.

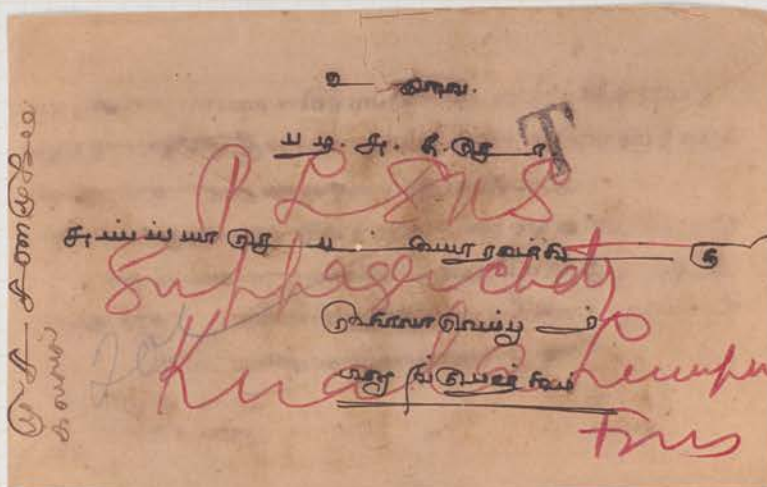


# MALAYA - FEDERATED MALAY STATES

Selangor

March 1923

Underpaid letter from Kallal, India to Kuala Lumpur, Selangor, Malaya postmarked 8 MAR 23 on the reverse on a copy of the 1 Anna of 1911. The rate was 2 Annas and the deficiency 1 Anna. On the obverse is an Indian "T" (Taxe) mark and a manuscript "20c" to indicate double the deficiency in gold centimes. On the reverse there is a Kuala Lumpur arrival mark of 24 MR 1923 and a postage due mark (in purple) "Kuala Lumpur/ 8 Cts./ To pay" indicating that postage due of 8 cents was charged.



# MALAYA - FEDERATED MALAY STATES

Negri Sembilan

March 1923

Indian PSE (local rate of 1 Anna) from Madras, India to Seremban, Negri Sembilan, Malaya postmarked 11 March 1923. The rate was 2 Annas and the deficiency 1 Anna. On the obverse is an Indian "T" (Tax) mark and a manuscript "20c" to indicate double the deficiency in gold centimes.

On the reverse there is a Seremban arrival mark of 24 March 1923. The purple postage due mark "Seremban/ 8 Cts./ To pay" indicating that postage due of 8 cents was charged is on the obverse.



# MALAYA - FEDERATED MALAY STATES

Selangor

April 1923

Unpaid letter from Kilasavalpatti, India to Klang, Selangor, Malaya postmarked 5 April 1923 on the reverse. The rate and the deficiency was 2 Annas. On the obverse there is an Indian "T" (Taxe) mark and a manuscript "40c" to indicate double the deficiency in gold centimes. On the reverse there is a Kuala Lumpur transit mark of 22 April 1923 and an arrival mark of Klang of 24 April 1923. There is on the obverse a boxed "Kuala Lumpur/ 10 cents/ To pay" postage due mark applied in transit indicating that postage due of 10 cents was charged.





# MALAYA - FEDERATED MALAY STATES

Perak

April 1923

Unpaid letter from Attangudi, Ramnad, India to Ipoh, Perak, Malaya postmarked 6 APR 23 with an transit mark of Konapet of 7 AP 23 both on the reverse. The rate and the deficiency was 2 Annas. On the obverse there is an Indian "T" (Tax) mark and a manuscript "40c" to indicate double the deficiency in gold centimes. On the reverse there is an Ipoh arrival mark of 21 AP 1923 and a boxed "Ipoh/ 10 cents/ To pay" postage due mark indicating the postage due that was charged.



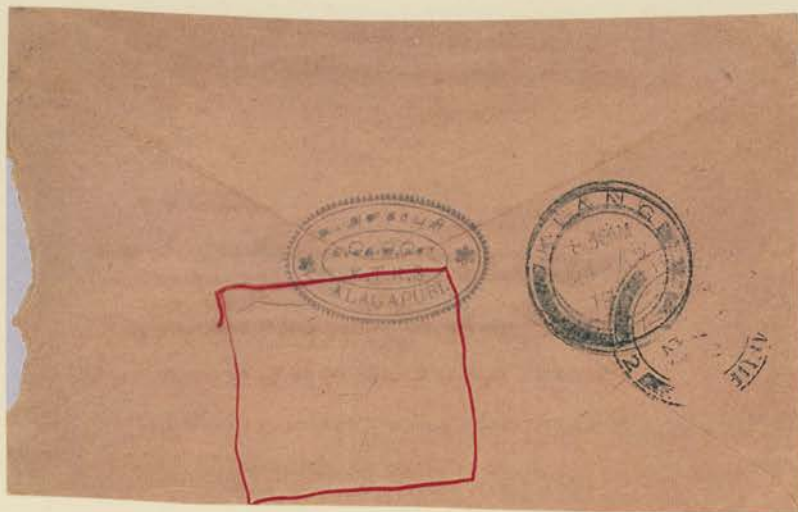
# MALAYA - FEDERATED MALAY STATES

Selangor

April 1923

Underpaid letter from India to Klang, Selangor, Malaya postmarked 4 April 1923 on copies of the ½ and 1½ Annas of 1911. The rate was 2 Annas so the deficiency was nil but mistakenly thought to be ½ Anna. There is an Indian "T" (Tax) mark and a manuscript "10c" to indicate double the mistaken deficiency in gold centimes.

On the reverse there is a Kuala Lumpur transit mark of 22 April 1923 and an arrival mark of Klang of 24 April 1923. There is on the obverse a boxed "Kuala Lumpur/ 8 Cts./ To pay" postage due mark applied in transit indicating that postage due of 8 cents was charged.



# MALAYA - FEDERATED MALAY STATES

Perak

May 1923

Unpaid letter from Kilasavalpatti, India to Taiping, Perak, Malaya postmarked 11 May 1923 on the reverse. The rate, and the deficiency, was 2 Annas. On the obverse there is an Indian "T" (Tax) mark and a manuscript "40c" to indicate double the deficiency in gold centimes. On the reverse there is a Taiping arrival mark of 18 May 1923 and a boxed postage due mark "Taiping/ 10 Cts./ To pay" indicating that postage due of 10 cents was charged.
