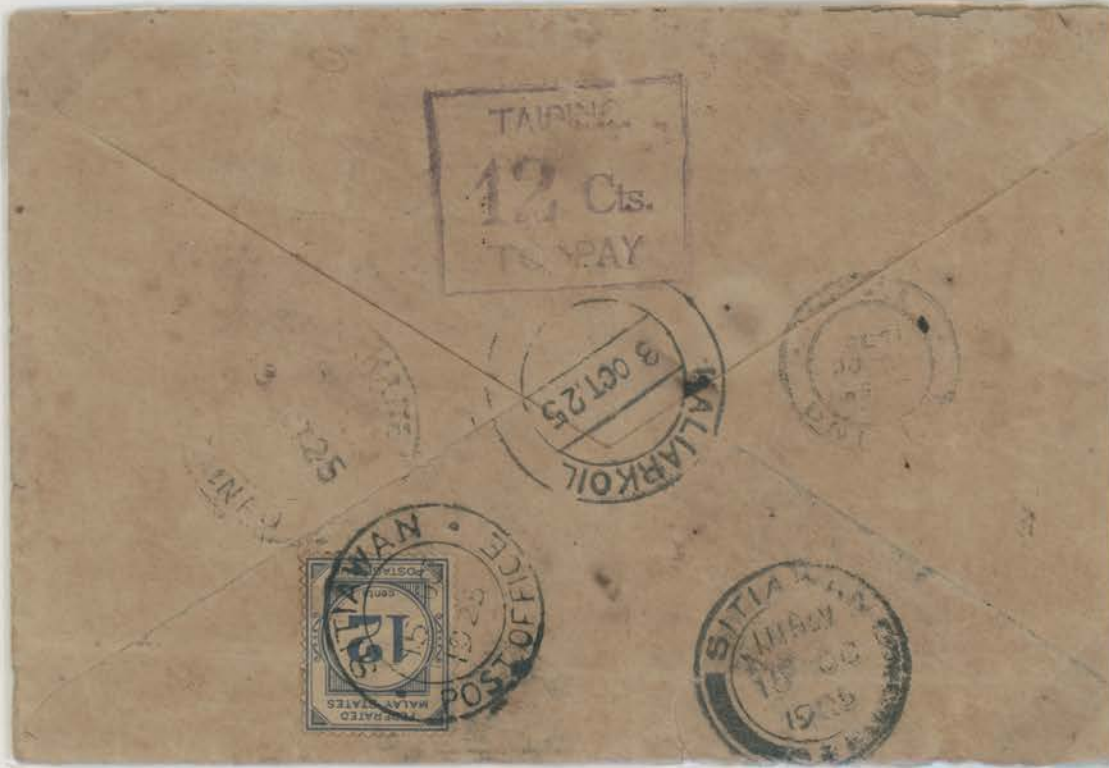


MALAYA - FEDERATED MALAY STATES

Perak

October 1925

Unpaid letter from Kaliarkoil, India to Sitiawan, Perak, Malaya postmarked 3 October 1925 on the reverse. The rate and the deficiency was 2 Annas. On the obverse are Indian "T" and "40C" (Taxe) marks indicating double the deficiency in gold centimes and a semicircular "Kaliakaoil/ Due/ As". On the reverse there is a boxed "Taiping/ 12 Cts/ To Pay" which was applied together with a postmark of Taiping on 15 October 1925. There are also two arrival marks of Sitiawan of 15 October 1925, one registered. The later is on a copy of the 12 cents FMS postage due stamp of 1924.



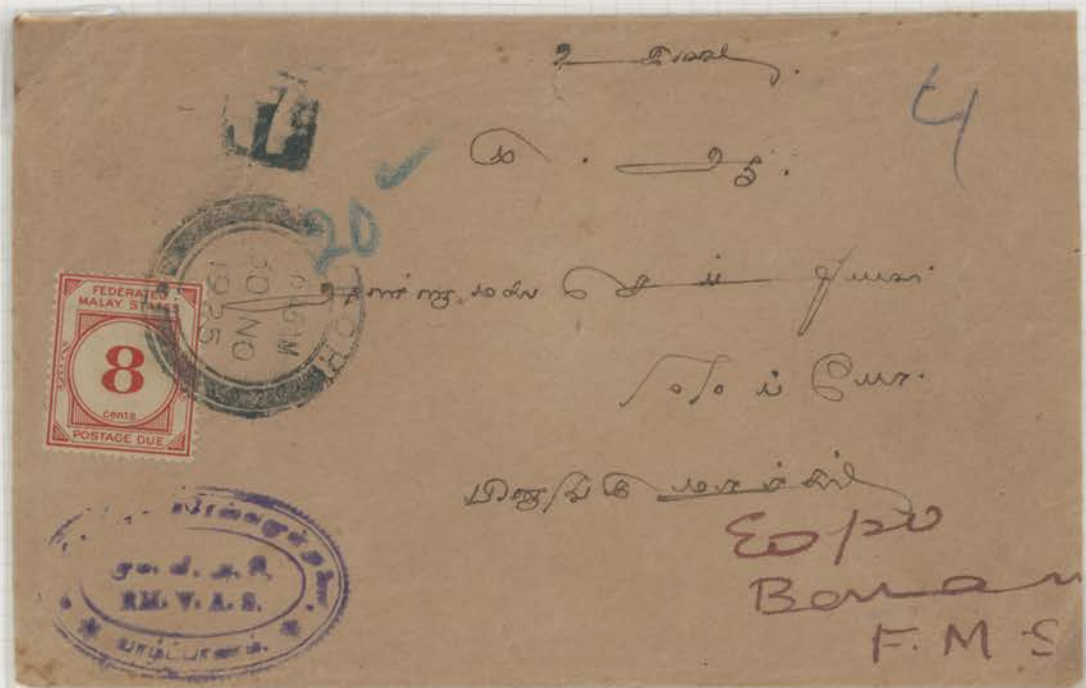
MALAYA - FEDERATED MALAY STATES

Perak

November 1925

Underpaid letter from Vannarponnai, Ceylon to Ipoh, Perak, Malaya partly paid by a copy of the 6 cents of 1922 on the reverse postmarked NO 18 25. The rate was 9 cents and the deficiency was 3 cents.

On the obverse is a Ceylonese "T" (Tax) mark and a blue manuscript "20c" indicating double the deficiency in gold centimes. There are arrival marks of Ipoh of 26 and 30 NO 1925 on the reverse and obverse. The later is on a copy of the 8 cents FMS postage due stamp of 1924.



MALAYA - FEDERATED MALAY STATES

Perak

November/December 1925

Unpaid letter from Sirukudappatti, Ramnad, India to Ipoh, Perak, Malaya postmarked 21 NOV 25 on the reverse. There is a transit mark of Tiruppattur of the same date. The rate and the deficiency was 2 Annas.

On the obverse is an Indian "40C/T" (Taxe) mark in a circle indicating the double the deficiency in gold centimes as well as a semi circular mark "Sirukudappatti/ Due/ As". On the reverse the arrival marks of Ipoh of 3 & 4 December 1925, the later on a copy of the 12 cents FMS postage due stamp of 1924.



FEDERATED MALAY STATES

Perak

November/December 1925

Underpaid PSE (internal rate of 1 Anna) from Kilasavalpatti, India to Ipoh, Perak, Malaya postmarked 28 NOV 25. The rate was 2 Annas and the deficiency 1 Anna.

On the obverse is an Indian "20C/T" (Taxe) mark in a circle indicating double the deficiency in gold centimes and a Ipoh mark of 11 DE 1925 on a copy of the FMS 8 cents postage due stamp of 1924.

On the reverse the arrival mark of Ipoh is 10 DE 1925.



MALAYA - FEDERATED MALAY STATES

Selangor

January 1926

Underpaid letter from Colombo, Ceylon to Klang, Selangor, Malaya. Postage partly paid by a horizontal pair of the 3 cents of 1923 postmarked 10 JAN 1926. The rate was 9 cents and the deficiency 3 cents. On the obverse there is a Ceylon "T" (Taxe) mark and a manuscript "20c" indicating double the deficiency in gold centimes. On the reverse the arrival marks of Klang of 16 JA 1926 are on a horizontal strip of four copies of the 2 cent Federated Malay States postage due stamp of 1924 (SGD2).



MALAYA - FEDERATED MALAY STATES

Selangor

January/February 1926

Unpaid letter from Tiruppattur, India to Kuala Lumpur, Selangor, Malaya postmarked 22 JAN 26 on the reverse. The rate and deficiency was 2 Annas.
On the obverse is an Indian "40C/ T" (Tax) mark indicating double the deficiency in gold centimes and a semi circular postage due "Tiruppattur (Ramnad)/ Due/ As" mark. On the reverse the arrival mark of Kuala Lumpur of 3 FE 1926 is on a copy of the 12 cents FMS postage due stamp of 1924.



MALAYA - FEDERATED MALAY STATES

Perak

January/February 1926

Indian KGV PSE (1 Anna on ½ Anna) from Devakottai, India to Teluk Anson, Perak, Malaya postmarked 27 JAN 26. The rate was 2 Annas and the deficiency 1 Anna.

Also on the obverse is an Indian "T" (Taxe) mark as well as a "20C" indicating double the deficiency in gold centimes. On the reverse there is an Ipoh transit mark of 6 FE 1926 and a Teluk Anson arrival mark of 7 FE 1926. There is a further Teluk Anson mark of 7 FEB 1926 on the obverse on a copy of the 8 cents FMS postage due stamp of 1924 and a blue manuscript "8".



MALAYA - FEDERATED MALAY STATES

Selangor

March 1926

Indian KGV PSE (internal rate of 1 Anna) from Madura, India to Kuala Lumpur, Selangor, Malaya postmarked 10 MAR 26. The rate was 2 Annas and the deficiency 1 Anna.

There are also an Indian "T" (taxe) and "20C" marks indicating double the deficiency in gold centimes. The Kuala Lumpur arrival mark of 20 [March 1926] was on a copy of the 8 cents FMS postage due stamp of 1924 which has been removed. Also on the reverse is a violet boxed Kuala Lumpur postage due mark "Kuala Lumpur/ 8 cts/ To pay" but the "To pay" in the last line did not print.



MALAYA - FEDERATED MALAY STATES

Selangor

April/May 1926

Indian KGV PSE (internal rate of 1 Anna) from Pudu, Ramnad, India to Kuala Lumpur, Selangor, Malaya postmarked 23 APR 26. The rate was 2 Annas and the deficiency 1 Anna.

Also on the obverse are Indian "T" (Taxe) and "20C" marks indicating double the deficiency in gold centimes. On the reverse there are an Indian transit mark of 23 APR 26, the Kuala Lumpur arrival mark of 3 MY 1926 on a copy of the 8 cents Federated Malay States postage due stamp of 1924 and a violet Kuala Lumpur postage due mark "Kuala Lumpur/ 8 cts/ To pay" with the last line not printing.



MALAYA - FEDERATED MALAY STATES

Perak

April 1926

Underpaid PPC (Kew Station Road) from Richmond, Surrey, England to Kampar, Perak, Malaya postmarked 1 APR 1926 on a copy of the 1d of 1924. The rate was 1½d and the deficiency was ½d. There is also a London "T/ 10/ L" (Tax) mark indicating double the deficiency in gold centimes. There is an Ipoh transit mark of 30 AP 1926 and the arrival mark of Kampar of 30 AP 1926 is on a horizontal pair of the 2 cents Federated Malay States postage due stamp of 1924.
