

MALAYA - FEDERATED MALAY STATES

Negri Sembilan

May 1933

Underpaid letter from India to Port Dickson, Negri Sembilan, Malaya postmarked 11 MAY.33 on the reverse on a copy of the 1 Anna of 1926. The rate was 2½ Annas and the deficiency 1½ Annas. On the obverse is an Indian “_C/T” (Taxe) mark in a circle. On the reverse there is a transit mark of Seremban and the Port Dickson arrival mark of 19 MY 1933, with the latter on a copy of the 12 cents FMS postage due stamp of 1924.



MALAYA - FEDERATED MALAY STATES

Perak

August 1933

Unpaid letter from Manamadura, Ramnad, India to Ipoh, Perak, Malaya postmarked 9 AUG.33.

The rate, and the deficiency, was 2½ Annas.

On the obverse there is an Indian "T/ 50-C" (tax) mark to denote double the deficiency in gold centimes.

On the reverse the Ipoh arrival mark of 17 AU 1933 is on one copy of the 2 cents and two copies of the 8 cents FMS postage due stamps of 1924.



MALAYA - FEDERATED MALAY STATES

Negri Sembilan

August/September 1933

Underpaid letter from Avinipatti, Ramnad, India to Kuala Pilah, Negri Sembilan, Malaya postmarked on the reverse 31 AUG.33 on a copy of the 1¼ Annas of 1932. The rate was 2½ Annas and the deficiency was 1¼ Annas. There is a transit mark of Kilasavalpatti of 31 AUG.33.

On the obverse is an Indian “_C/T” in a circle (Taxe) mark next to a manuscript “25c” indicating double the deficiency in gold centimes. The Kuala Pilah arrival mark on the reverse of 8 SP 1933 is on copies of the 4 cents and 8 cents FMS postage due stamps of 1924/26.

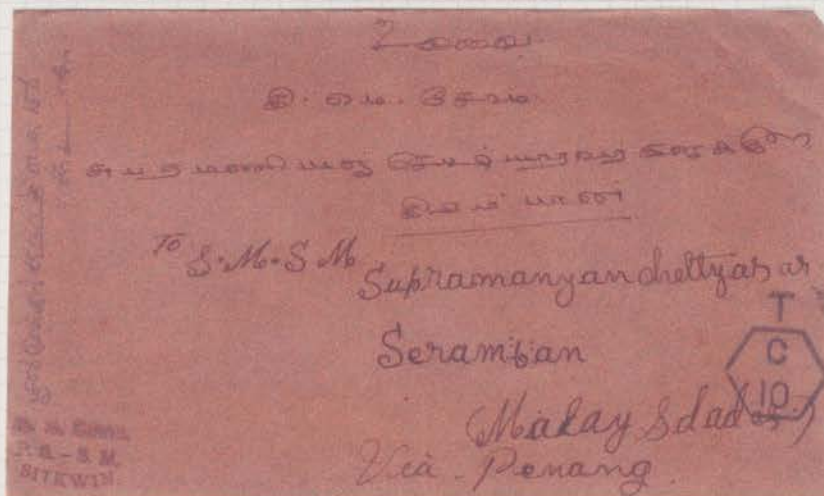

MALAYA - FEDERATED MALAY STATES

Negri Sembilan

November/December 1933

Underpaid letter from Sitkwin, Burma to Seremban, Negri Sembilan, Malaya partly paid by a pair of the Indian 1 Anna of 1926 postmarked 23 NOV.33. The rate was $2\frac{1}{2}$ Annas and the deficiency $\frac{1}{2}$ Anna. On the obverse is a Burmese "T/C/10" (Tax) mark in a hexagon indicating double the deficiency in gold centimes. The Seremban arrival mark of 4 DE 1933 is on a copy of the 4 cents FMS postage due stamp of 1926.



MALAYA - FEDERATED MALAY STATES - KEDAH

Selangor via Kedah

December 1933

Underpaid airmail letter from London, England to Kuala Lumpur, Selangor, Malaya partly paid by copies of the 2d and 6d of 1924/26 postmarked 8 DEC 1933 and endorsed "Via Singapore" and "1st flight London to Singapore 9.12.33". The rate was 11d and the deficiency 3d, resulting in a blue manuscript "T 60" mark indicating double the deficiency in gold centimes.

On the reverse there is an Alor Star, Kedah transit mark of 18 DE 1933 and the Kuala Lumpur arrival mark of 20 DE 1933 is on copies of the 10 cents and 12 cents FMS postage due stamps of 1924. On the obverse the letter is endorsed "Delivered Singapore on 19.12.33" and "Recd K.L. 20/12/33".



MALAYA - FEDERATED MALAY STATES

Perak

December 1933/January 1934

Airmail New Zealand George V PSE (local 1d rate) from Hawera, New Zealand partly uprated with a copy of the 3d airmail stamp of 1931 postmarked 11 DEC33 to Sitiawan, Perak, Malaya.

The rate was 5d and the deficiency 1d.

There is also a New Zealand "T/ 20/ centimes" (Taxe) mark in a circle indicating double the deficiency in gold centimes. On the reverse the Sitiawan arrival mark of 8 JA 1934 is on a copy of the 8 cents FMS postage due stamp of 1924.



MALAYA - FEDERATED MALAY STATES

Selangor

December 1933/January 1934

Local 9 pies rate postcard from Kondanoor, India to Klang, Selangor, Malaya partly uprated with a copy of the 9 pies of 1932 postmarked 27 DEC.33. The rate was 2 Annas and the deficiency ½ Anna. There is an Indian "10 C/T" (Tax) mark in a circle indicating double the deficiency in gold centimes. The Klang arrival mark of 5 JA 1934 is on a copy of the 4 cents FMS postage due stamp of 1926.



MALAYA - FEDERATED MALAY STATES

Selangor

January 1934

Underpaid PSE (internal rate of 1¼ Annas) from Attangudi, India to Kuala Lumpur, Selangor, Malaya postmarked 18 January 1934. The rate was 2½ Annas and the deficiency 1¼ Annas. On the obverse there is an Indian "25 C/T" (Taxe) mark in a circle indicating double the deficiency in gold centimes. The Kuala Lumpur arrival mark of JA 1934 is on a copy of the 12 cents FMS postage due stamp of 1924.

MALAYA - FEDERATED MALAY STATES

Perak

March 1934

Underpaid letter from Teriruveli, Ramnad, India to Ipoh, Perak, Malaya partly paid with a copy of the 1 Anna of 1926 on the reverse postmarked 6 MAR.34 with a transit mark of Ramnad alongside.

The rate was 2½ Annas and the deficiency 1½ Annas.

On the obverse there is a manuscript "T 30C" (taxe) mark to indicate double the deficiency in gold centimes and a "Teriruveli/ Due/ Two Annas" mark in a semi circle. On the reverse the Ipoh arrival mark of 15 MR 1934 is on a copy of the FMS 12 cents postage due stamp of 1924.



MALAYA - FEDERATED MALAY STATES

Perak

May 1934

Underpaid envelope from Palni-Adivaham, Madras, India to Sitiawan, Perak, Malaya partly paid by a copy of the 1 Anna of 1926 postmarked 17 MAY.34. The rate was 2½ Annas and the deficiency 1½ Annas.

There is also an Indian "10C/T" (Taxe) mark in a circle indicating incorrectly double the deficiency in gold centimes. The Sitiawan arrival mark of 25 MY 1934 is on a copy of the 4 cents postage due stamp of the FMS of 1926 on the reverse.
